RECOMMENDED PROCEDURE:

1. MIRU; blowdown tubing and casing. NU BOP. Release packer and POH
 2. PU 5 ½" 10k tbg set CIBP and work string. RIH, set CIBP @ +/- 4,100'. Release tbg from CIBP and circ w/ mud and cap w/ 10 sx cement. Pull up hole.
 3. Locate EOT @ 3,000', mix and spot 50 sx cement to cover 8 5/8" shoe & 5 ½" liner top. POH w/ tb.
 4. Cut & pull free 8 5/8" casing +/- 1,710'. *If not free perf & squeeze @ 1,710'.
 5. Run tubing & spot following cement plugs:
 - a. 1710' – 80 sx cement
 - b. 600' – 70 sx cement
 - c. 64-4' 50 sx cement
 6. RDSU cut & cap well. Dig up rig anchors.

Dear Sharon Sequera:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after November 23, 2021. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The November 23, 2021 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
