Charles,

I spoke with Steve VanGieson our UIC officer about the 300 psi product and it sounds to us like it may have set up in the well, and is not allowing you to pull the tubing. With that said we **do not** want you to shoot the tubing off. Since the well would not pressure up for an MIT, there must be a hole either in the casing or tubing. Tie onto the tubing and see if you can pump down the tubing, **or** if it comes around on the backside. If it comes around on the backside like a tubing leak, then we will formulate a different plugging plan. If it does not appear to be a tubing leak, then we will allow you to pump your cement down the tubing and below the packer for a bottom plug. We would then allow you to tie onto the backside of the 4 ½" casing and bullhead cement down the annulus between the tubing and 4 ½' casing. We only allow that since the 4 ½" casing is cemented top to bottom. (I have a copy of the cement ticket.) This would mean you can leave your tubing full of cement.

When you get back over the well and pump down the tubing, please give me a call to let me know the results.

Dear Charles Kremeier:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 2 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 2's phone number is (316) 337-7400. Failure to notify DISTRICT 2, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after March 20, 2022. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The March 20, 2022 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
