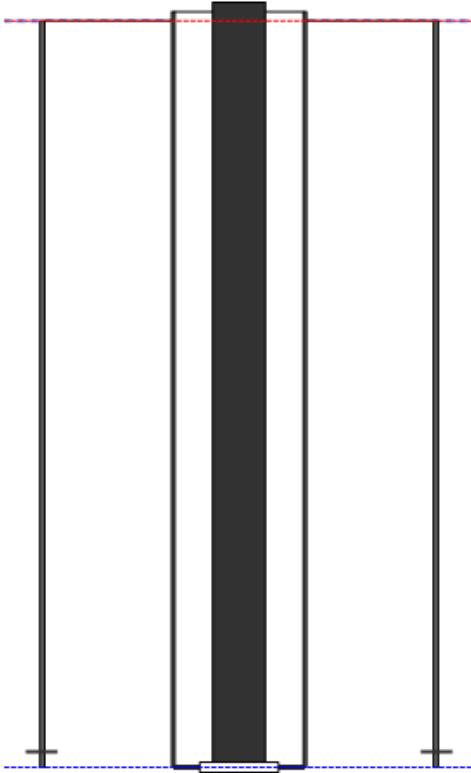

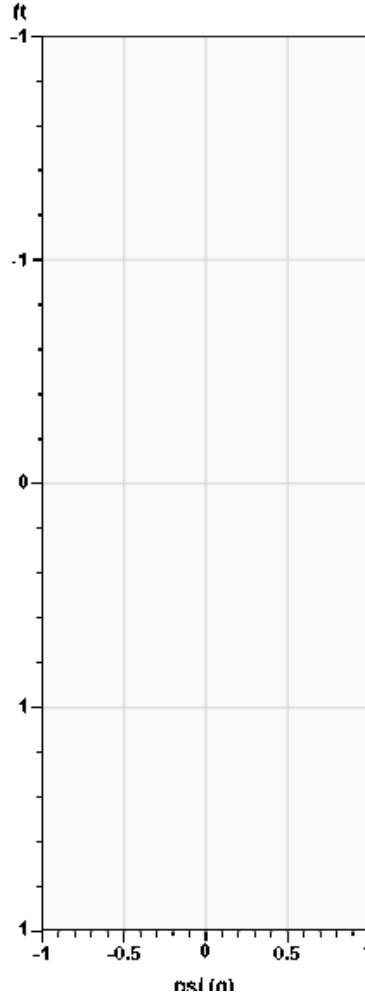

**Static Bottomhole Pressure**

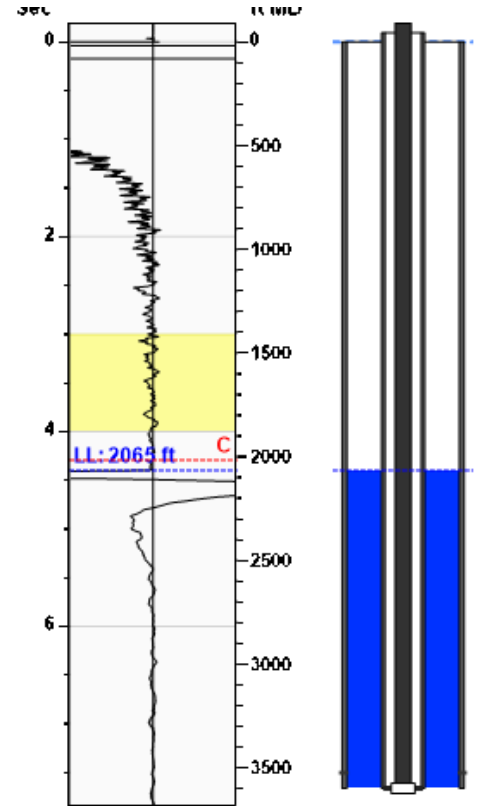

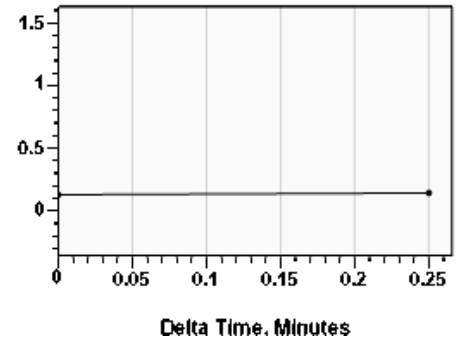
**Pressure Profile (TVD)**
