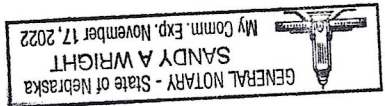

Lots Two (2), Five (5), and Six (6) and part of the Southeast Quarter (SE/4) lying West of the Center of Topliff's Creek and all that part of the West Half (W/2) lying South of the Arkansas River and East of the railroad right-of-way of the A.T. & S.F. Railroad less tracts 30, 31, and 32 of Holmes Orchard and Garden Tracts of Section Six (6), Township Thirty-five (35) South, Range Four (4) East, *known as* the BERGKAMP.

The East Half of the Northeast Quarter (E/2 NE/4) of Section Seven (7) and the Northwest Quarter (NW/4) of Section (8), Township Thirty-five (35) South, Range Four (4) East, *known as* the BROCE.

The West Half of the Southwest Quarter (W/2 SW/4) of Section Eight (8), Township Thirty-five (35) South, Range Four (4) East, *known as* the KLINK "B".
