Mixed 110 SKS 60/40 Pozmix Cement w/ 4% Gel @ 14#/gal, yield 1.40 = 27 Bbl slurry. Good cement returns to surface on annulus of 5 1/2". Shut down. 5 1/2" + annulus standing full of cement. Job complete. Rig down.
