HCU 0820-B Plugging Procedure

1. MIRU PU. MIRU WL Unit. RIH w/ free-point tool to determine the depth of stuck tbg. Notify KCC where tbg is free and ask for approval to cut at depth. 2,300' deep would be ideal.
2. POOH w/ free tbg.
3. RIH w/ 4.5" wiper plug & set on top of stuck tbg.
4. MIRU Cement Unit. Circulate cmt to surface with ~175 sx & 300# hulls
5. TOOH with tbg & top off 4-1/2" csg with cmt.
6. Attempt to pump cmt down the 4-1/2" x 8-5/8" annulus.

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after October 09, 2022. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The October 09, 2022 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
