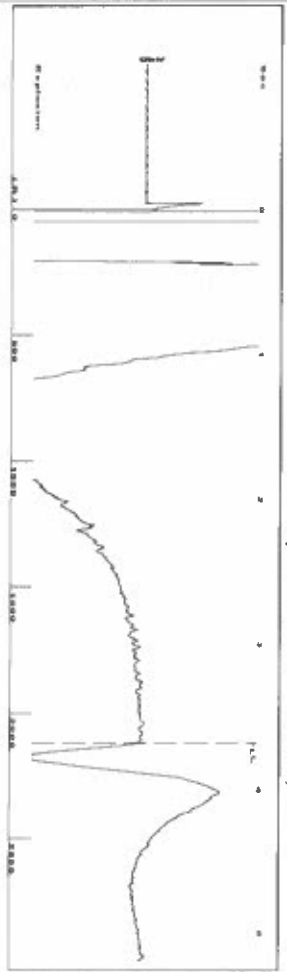

Liquid level calculated with user supplied Acoustic Velocity

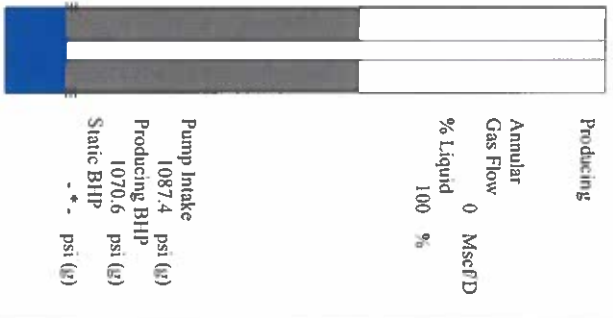
Acoustic Velocity 1150 ft/s

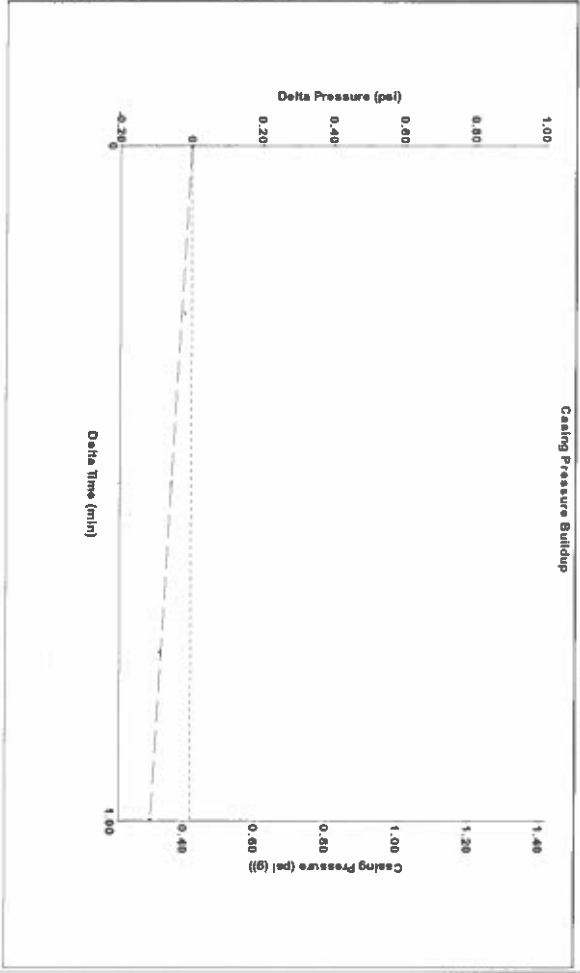
