<p>Plug Job Move to location, long stroked pump, got fluid to surface. Pull out rods in single and laid out on ground, pulled tubing up, started to pump. Pumped 2 sacks of gel, then started to pump cement with cotton seed hulls, pumped 5 barrels of cement, pulled up to 500' and pumped 1 barrel, then came up to 250' and filled to surface with 5 barrels of cement. Got good cement to surface, pulled rest of pipe, topped well off with 2 barrels of cement. Cement stayed at surface, laid pipe out on ground for the land owner.
