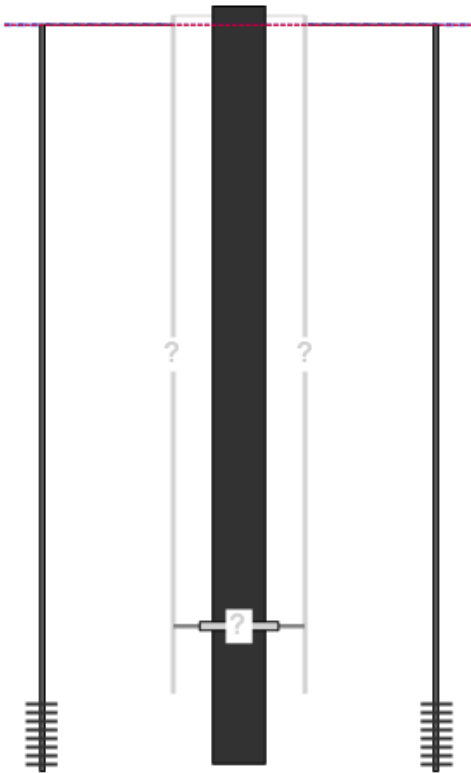

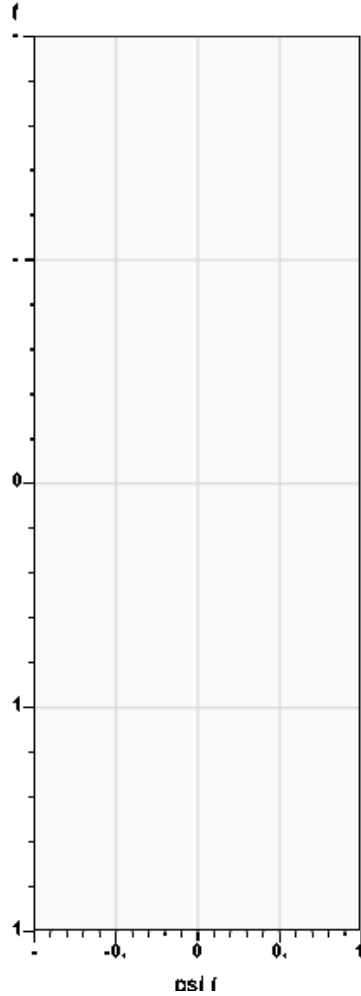

Static Bottomhole Pressure

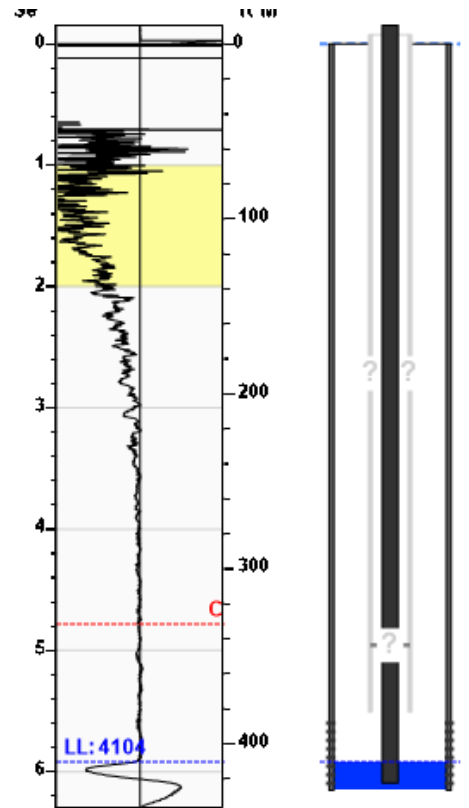
