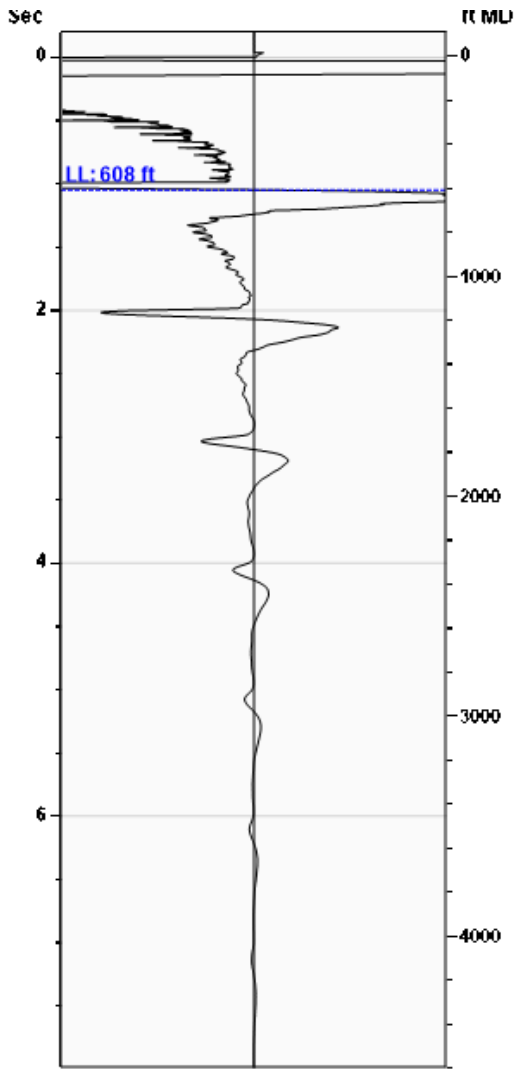

Fluid Above Pump

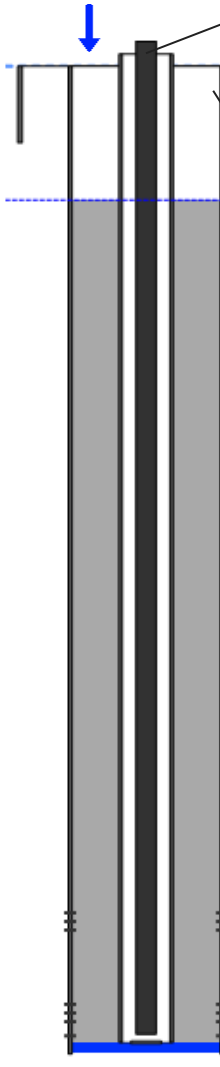
