



Each operator shall perform one of the following when disposing of dike or pit (a) contents: Remove the liquid contents to a disposal well or other oil and gas operation (1) approved by the commission or to road maintenance or construction locations approved by the department: dispose of reserve pit waste down the annular space of a well completed (2)according to the alternate I requirements of K.A.R. 82-3-106, if the waste to be disposed of was generated during the drilling and completion of the well; or dispose of the remaining solid contents in any manner required by the (3)commission. The requirements may include any of the following: Burial in place, in accordance with the grading and restoration (A) requirements in K.A.R. 82-3-602 (f); removal and placement of the contents in an on-site disposal area (B) approved by the commission; (C) removal and placement of the contents in an off-site disposal area on acreage owned by the same landowner or to another producing lease or unit operated by the same operator, if prior written permission from the landowner has been obtained; or removal of the contents to a permitted off-site disposal area approved (D) by the department. (b) Each violation of this regulation shall be punishable by the following: A \$1,000 penalty for the first violation; (1) a \$2,500 penalty for the second violation; and (2)a \$5,000 penalty and an operator license review for the third violation.
