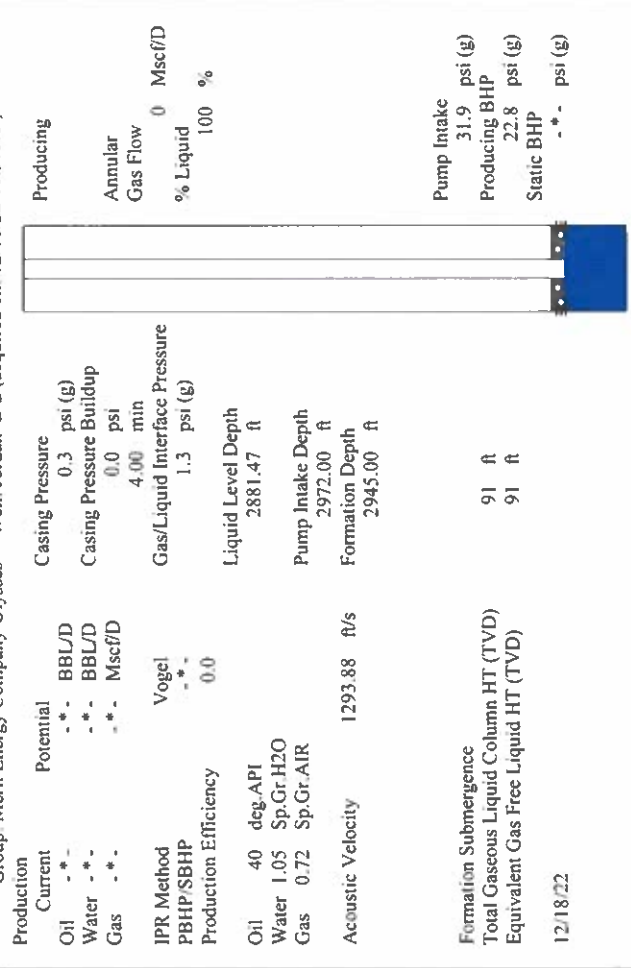

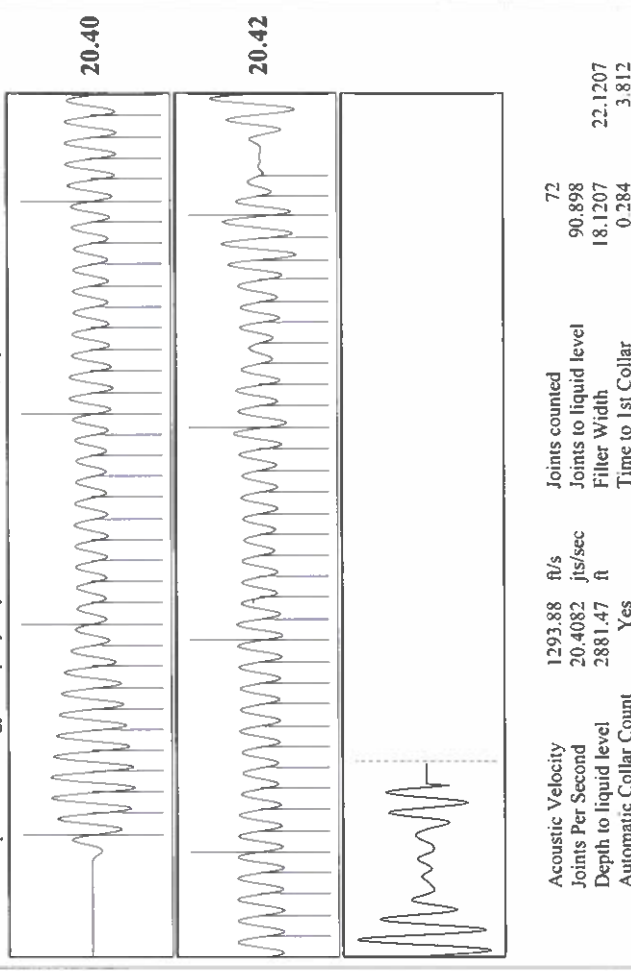


Casing Pressure Buildup
