Load hole with salt water.

Work casing. Free point casing. 50% free at 1300'.

Cut casing off at 1250'.

Pull 2 joints to 1166'.

Rig up Franks Oilfield Service. Pumped 260 sacks with 300# of hulls.

Pulled casing to 580' pumped 135 sacks with 300# of hulls.

Pulled rest of casing. Pumped 55 sacks to top off 8 5/8".

Recovered 29 joints + 15' of the 30th joint.

Rig down Franks Oilfield Service.
