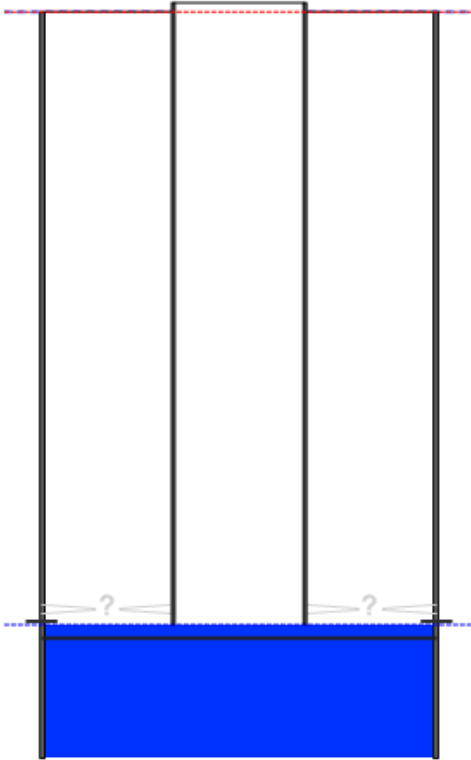

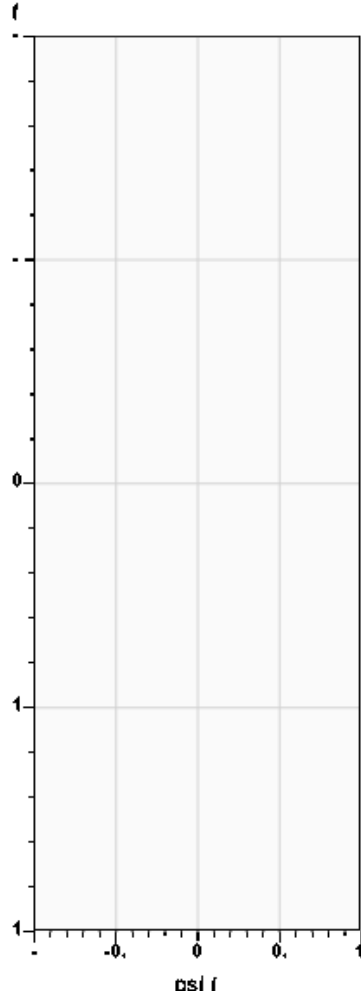

Static Bottomhole Pressure

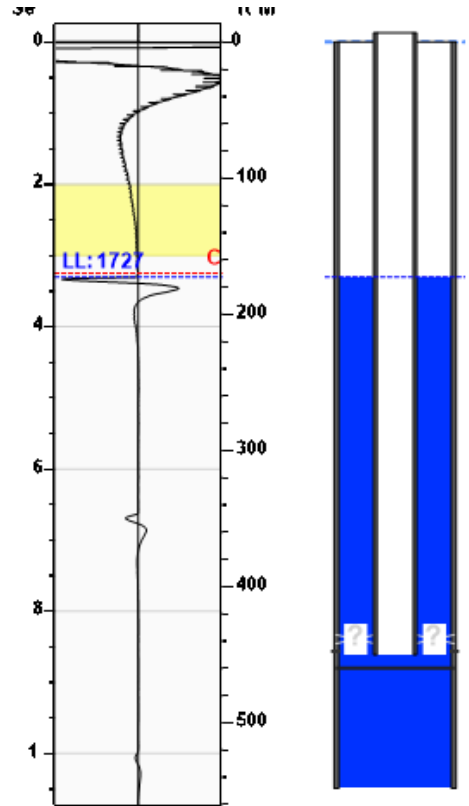

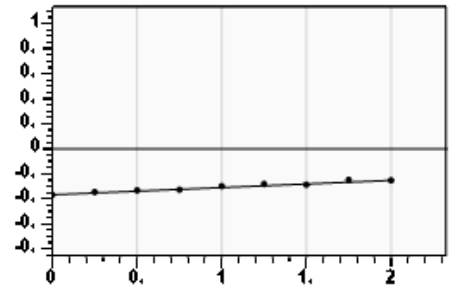
Pressure Profile (TVD)
