Release Top Rubber Plug. Displace plug 7' seat w/ 5 Bbl fresh water. Final pumping pressure of 200 PSI. Pump plug to 700 PSI. Wait 2 min. Release pressure. Float & plug held. Good cement returns to surface = 3 Bbl slurry to pit. Tubing 1/4" Pig down.
