AFFIDAVIT

The undersigned hereby affirms that the drilling, completion and eventual plugging of this well will comply with K.S.A. 55 et. seq.

It is agreed that the following minimum requirements will be met:

1. Notify the appropriate district office **prior** to spudding of well;
2. A copy of the approved notice of intent to drill **shall be** posted on each drilling rig;
3. The minimum amount of surface pipe as specified below **shall be set** by circulating cement to the top; in all cases surface pipe **shall be set** through all unconsolidated materials plus a minimum of 20 feet into the underlying formation.
4. If the well is dry hole, an agreement between the operator and the district office on plug length and placement is necessary **prior to plugging**;
5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;
6. If an ALTERNATE II COMPLETION, production pipe shall be cemented from below any usable water to surface within **120 DAYS** of spud date. Or pursuant to Appendix "B" - Eastern Kansas surface casing order #133,891-C, which applies to the KCC District 3 area, alternate II cementing must be completed within 30 days of the spud date or the well shall be plugged. **In all cases, NOTIFY district office** prior to any cementing.

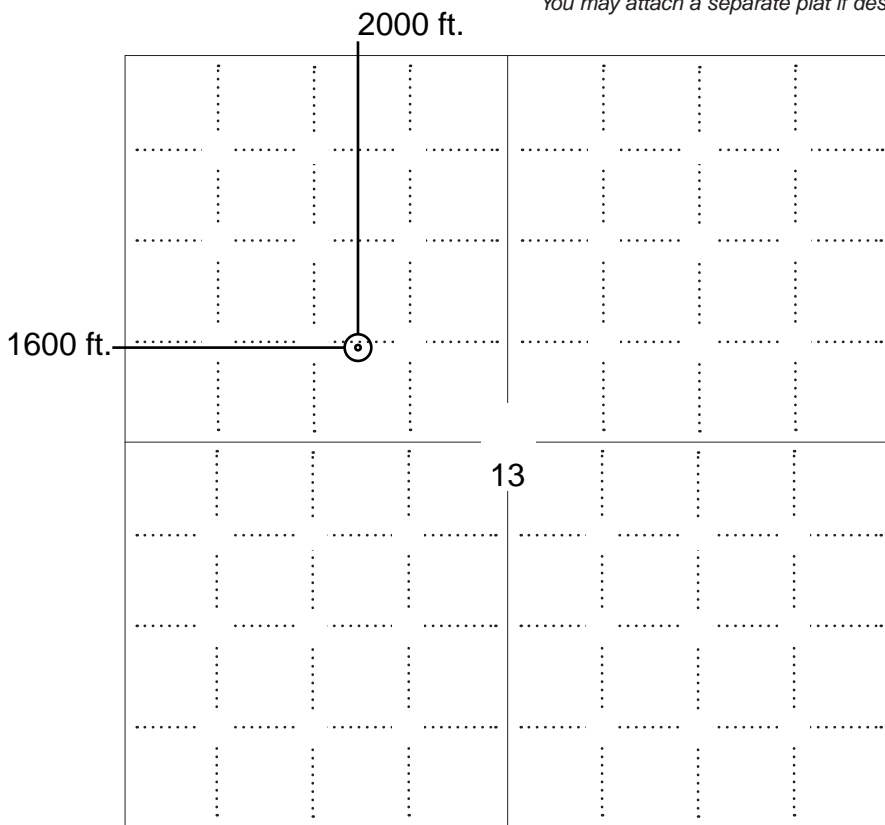

DIRECTIONS: From Oberlin, Ks. at the intersection of Hwy 83 & Hwy 36 – go 5 miles west on Hwy 36 – now go 3 miles north on 314 Rd. to the southeast corner of section 13-02s-30w – now go 0.8 miles west on V Ln. – now follow meandering lease trail in a northerly direction for approx. 0.7 miles to pumpjack – continue on lease trail for another 0.2 mile to an ingress stake marked “east into” – now go approx. 100’ east up the hill to ingress stake “ESE into” – now go approx. 500’ ESE to an ingress stake at fence line (fence will need removed) marked “east into” – now go approx. 400’ east though wheat field into staked location
