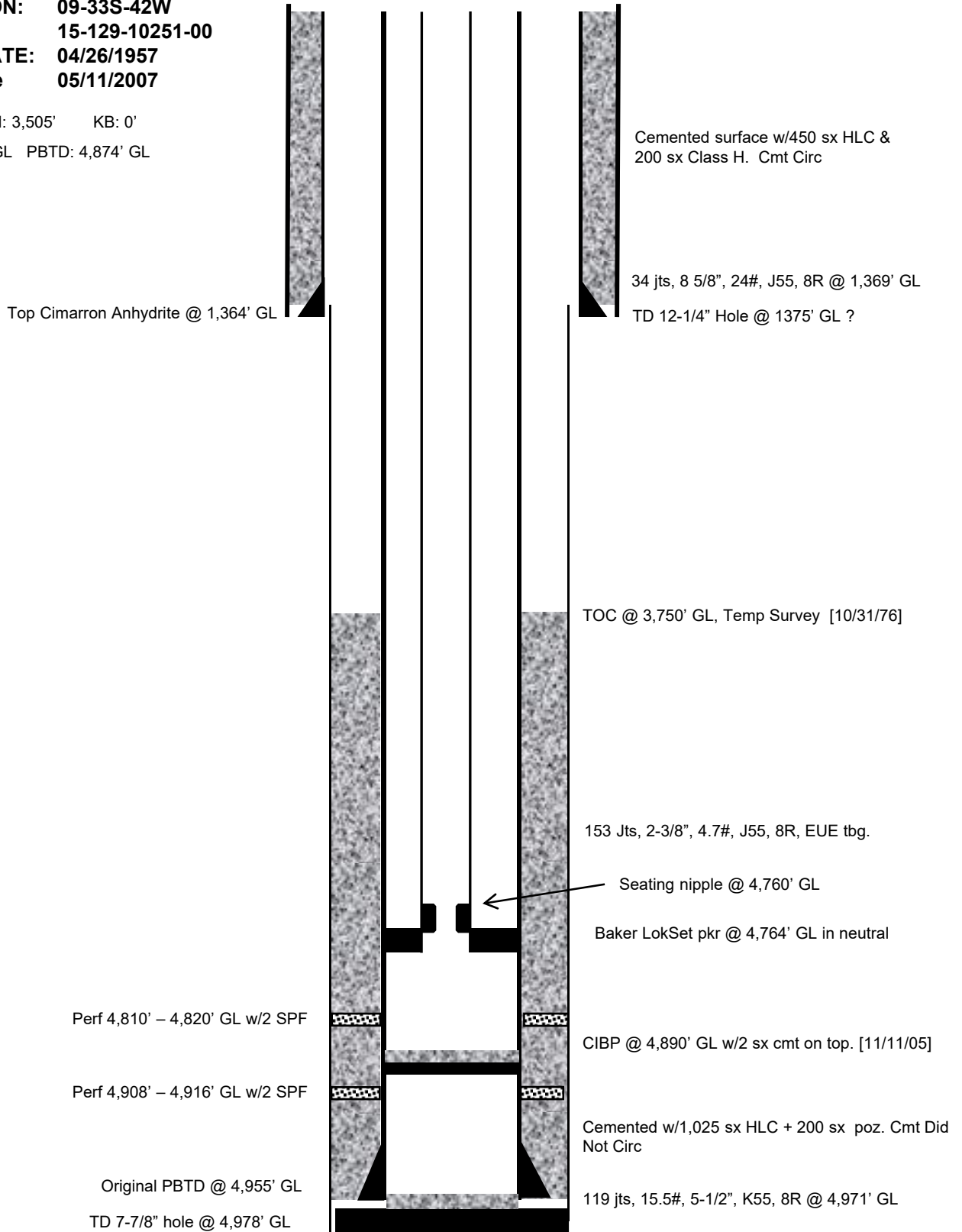

Plugging prognosis Boehm 39

- Pull existing tubing and packer out of the hole
- Tally and run tubing string in the hole
- Tag PBTD at 4,874' +/-
- Mix and spot 25 sacks thru tubing
- Pull tubing up hole, and circulate hole full of fresh 9# gel or mud
- Wait 4 hours, and then drop in to tag cement top. Cement top should be 4,760' or higher. If not, mix and spot more cement to cover the perms.
- Pull tubing up to 3,800'
- Mix and spot balanced plug with 25 sacks
- Pull tubing out of the hole
- Perforate casing at 1,420'
- Run un with retainer and set retainer at 1,320'
- Mix and spot 45 sacks of cement, 40 sacks thru retainer and then 5 sacks on top of retainer
- Pull tubing out
- Perforate casing @100'
- Tie on to casing
- Mix and circulate cement down casing and up the surface pipe, approx. 40 sacks of cement
- Clean up

Cut and cap a few days later per KCC rules

Dear Kevin Lively:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 682-7933. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after December 25, 2023. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The December 25, 2023 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
