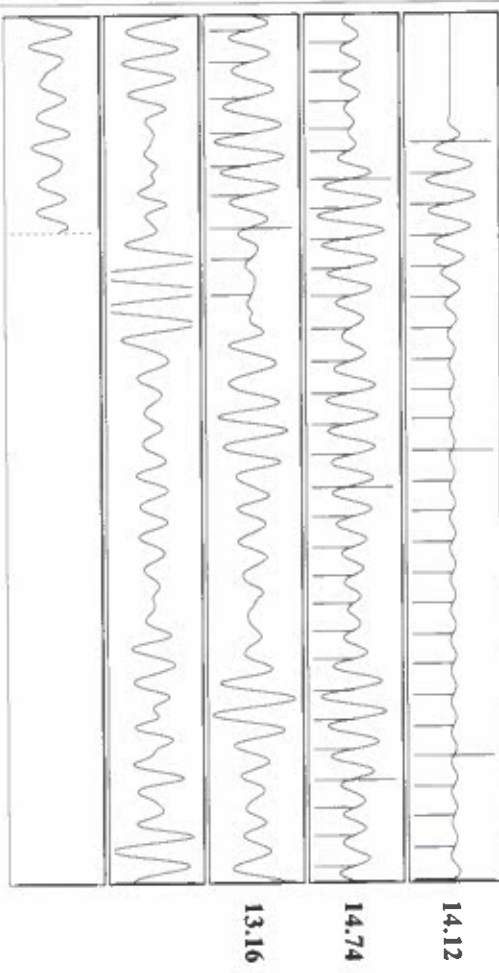


Pump Intake 617.0 psi (g)
