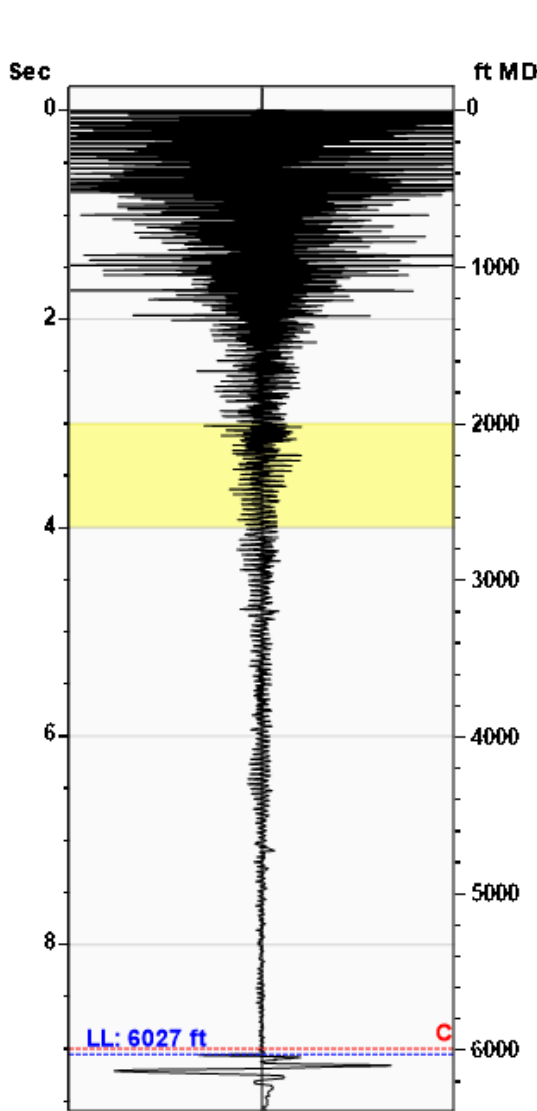

Liquid Level

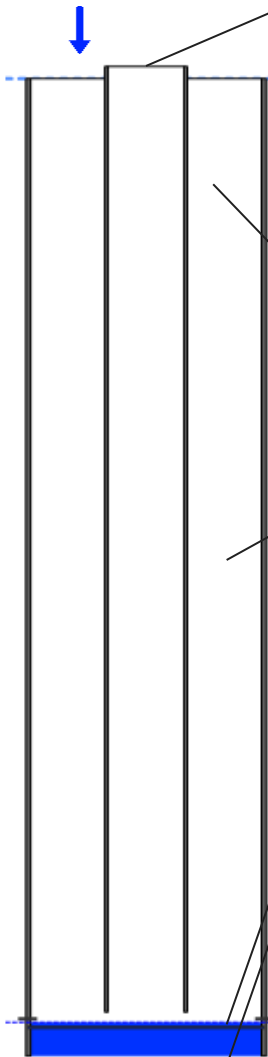

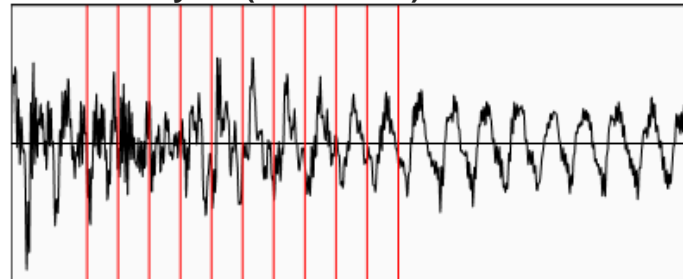

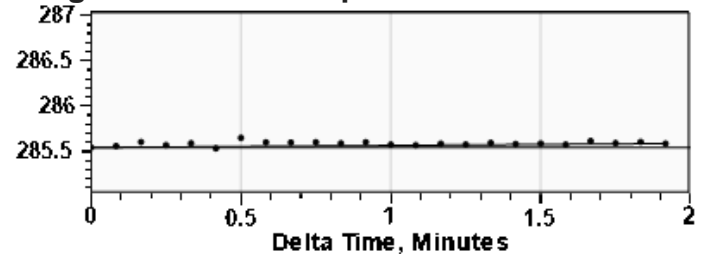
