OIL AND GAS LEASE

AGREEMENT, made EFFECTIVE on the 19th day of May, 2018, by and between J. Harry Peckham and Juanita Peckham, husband and wife, Charles A. Peckham and Connie Pectro, aw husband and wife and Linda I. Peckham with Single. What husband. Parties of the first part, hereinafter collectively called lessor (whether one or more) and LH OIL, LLC, Party of the second part, hereinafter called lessee.

Township 17 South Range 21 East
All of the part of the NE ½ of Sec. 16, Lying N. of the Marais
Des Cygnes River; also, all of the land tying E. of Turkey Creek
in the S. ½ of the SE ¼ of Sec. 9, and the NE ¼ of the SE ¼ of
Sec. 9.

It is agreed that this lease shall remain in full force, after expiration of the _______ year primary term, as long as oil or gas, or either of them, is produced from said land by the lessee.

In consideration of the premises the said lessee covenants and agrees:

1st. To deliver to the credit of lessor, free of cost, in the pipe line to which he may connect

his wells, the equal 14% part of all oil produced and saved from the leased premises.

2nd. To pay lessor for gas from each well where gas only is found the equal of 14% of the gross proceeds at the prevailing market rate, for all gas used off the premises, said payments to be made monthly and lessor to have gas free of cost from any such well for all stoves and all inside lights in the principal dwalling house on said land during the same time by making his own connections with the well at his own risk and expense.

3rd. To pay lessor for gas produced from any oil well and used off the premises or in the manufacture of gasoline or any other product a royalty of 14% of the market value, at the mouth

of the well, payable monthly at the prevailing market price.

Should the first well drilled on the above described land be a dry hole, then, and in that event, if a second well is not commenced on said land within twelve months from the expiration of the last rental period for which rental has been paid, this lease shall terminate as to both parties, unless the lessee on or before the expiration of said twelve months shall resume the payment of rentals in the same amount and in the same manner as hereinbefore provided. And it is agreed that upon the resumption of the payment of rentals, as above provided, that the last preceding

paragraph hereof, governing the payment of rentals and the effect thereof, shall continue in force just as though there had been no interruption in the rental payments.

If said lessor owns a less interest in the above described land than the entire and undivided fee simple estate therein, then the royalties and rentals herein provided shall be paid the lessor

only in the proportion which his interest bears to the whole and undivided fee.

Lessee shall have the right to use, free of cost, gas, oil and water produced on said land for its operation thereon, except water from wells of lessor.

When requested by lessor, lessee shall bury his pipe lines below plow depth.

No well shall be drilled nearer than 200 feet to the house or barn now on said premises, without the written consent of the lessor.

Lessee shall pay for damages caused by its operations to growing crops on said land.

Lessee shall have the right at any time to remove all machinery and fixtures placed on said

premises, including the right to draw and remove casing.

If the lessee shall commence to drill a well within the term of this lease or any extension thereof, the lessee shall have the right to drill such well to completion with reasonable diligence and dispatch, and if oil or gas, or either of them, be found in paying quantities, this lease shall continue and be in force with the like affect as if such well had been completed within the term of years herein first mentioned.

If the estate of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed, the covenants hereof shall extend to their heirs, executors, administrators, successors or assigns, but no change in the ownership of the land or assignment of rentals or royalties shall be binding; and it is hereby agreed in the event this lease shall be assigned as to a part of as to parts of the above described lands and the assignee or assignees of such part of parts shall fail or make default in the payment of the proportionate part of the rents due from him or them on an acreage basis, such default shall not operate to defeat or affect this lease in so far as it covers a part of parts of said lands upon which the said lessee or any assignee thereof shall make due payments of said rentals. If the leased premises are now or hereafter owned in severalty or in separate tracts, the premises, nevertheless, may be developed and operated as an entirety, and the royalties shall be paid to each separate owner in the proportion that the acreage owned by him bears to the entire leased area. There shall be no obligation on the part of the lessee to offset wells on separate tracts into which the land covered by this lease may hereafter be divided by sale, devise, or otherwise, or to furnish separate measuring or receiving tanks for the oil produced from such separate tracts.

Lessor hereby warrants and agrees to defend the title to the lands herein described, and agrees that the lessee shall have the right at any time to redeem for lessor by payment, any mortgages, taxes or other liens on the above described lands, in the event of default of payment by lessor, and be subrogated to the rights of the holder thereof.

In the event lessee should make assignment of this lease in whole or in part to third pary unrelated to lessor as such assignment shall take affect until lessee or its assigns pays to lessor the sum of \$300.00. Failure to pay lessor said \$300.00 shall void any assignment of this lease.

Lessor makes no claim of ownership to any oil and gas producing equipment now located upon the leasehold premises. This lease should permit lessee to enter lessor's premisis and rework and use any existing wells without further consent or payment to lessors.
