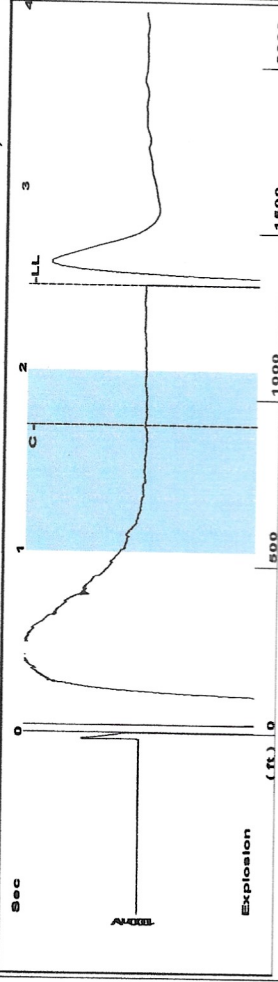

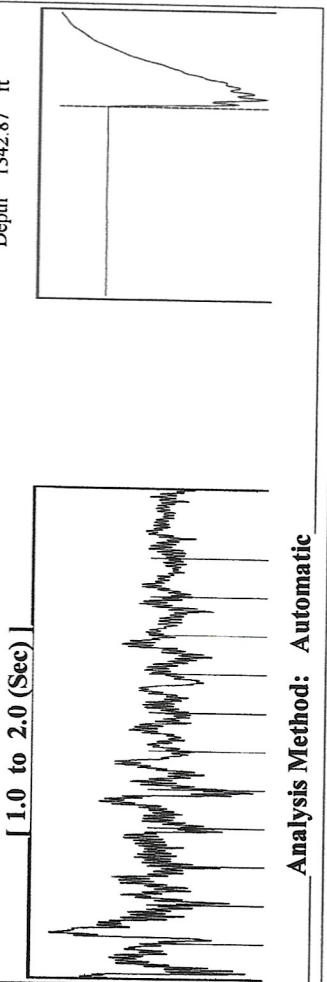
Delta Pressure (psi) vs Delta Time (min)

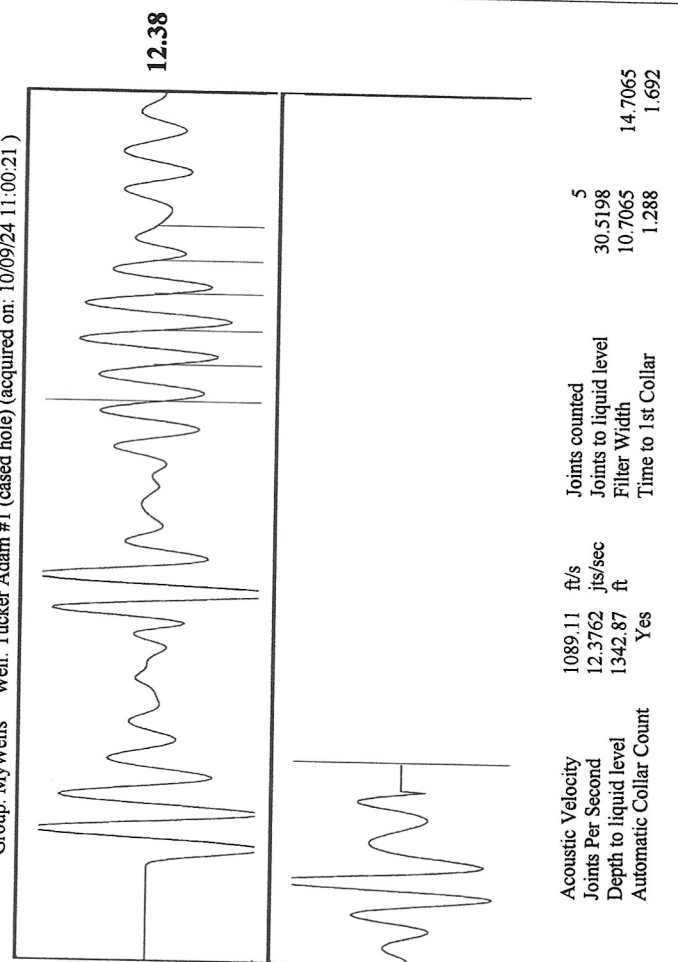
Acoustic Velocity vs Depth
