ASSIGNMENT OF OIL AND GAS LEASE

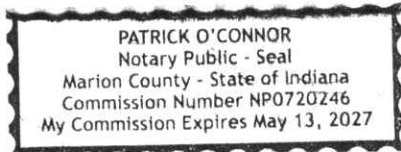
KNOW ALL MEN BY THESE PRESENTS:
