We would like to request formally that the Temporary Abandonment application be approved. We just purchased this package of wells within the last few months with the intention of reworking and producing the wells. The wells all have active leases and exceptional behind the pipe potential that's already cemented, which minimizes the amount of work required to recomplete and produce the wells.

We ask for this approval so that we have time to get AFE's approved by our investors and working interest partners before we begin work on the wells. Some of these wells are producing as is, just need minor things such as pump changes. The former operator, as part of the purchase agreement, kept some of the surface equipment. Over the next few months we'll be reinstalling pumping units and whatever else they kept.

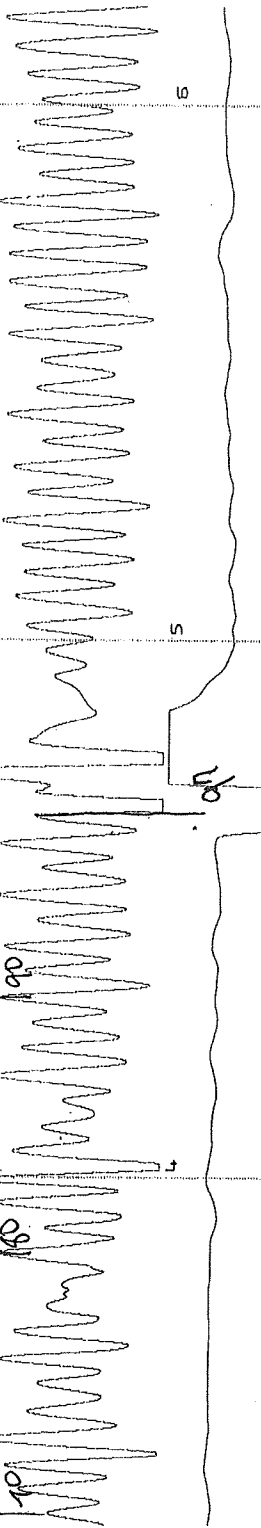
