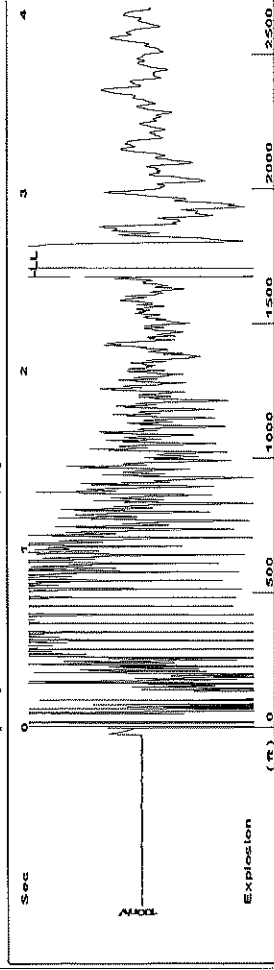

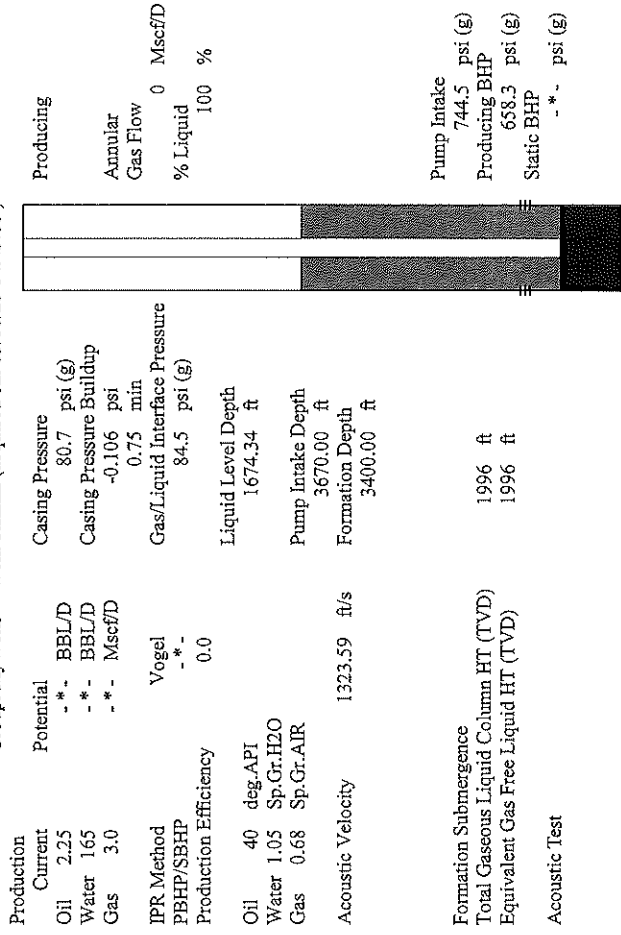

user supplied Acoustic Velocity

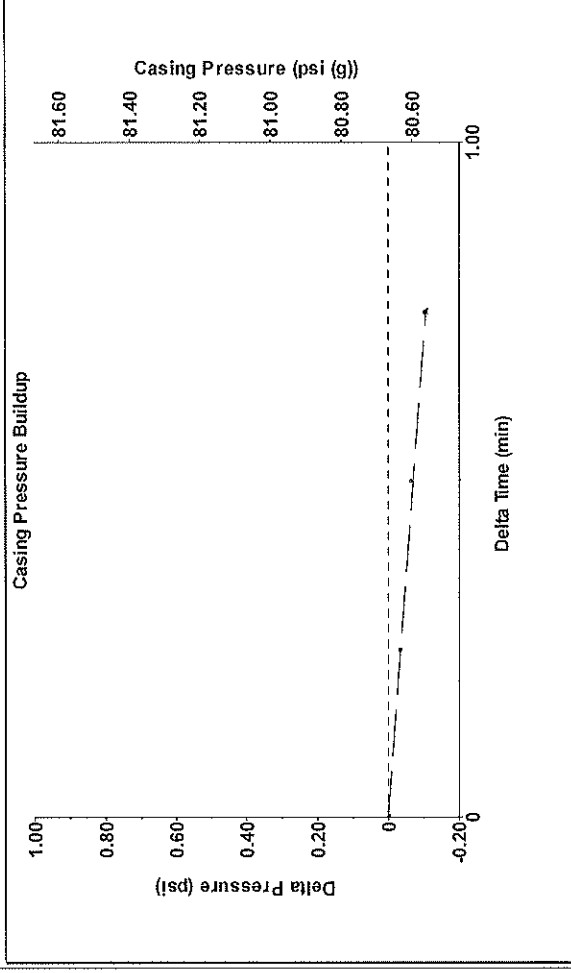
