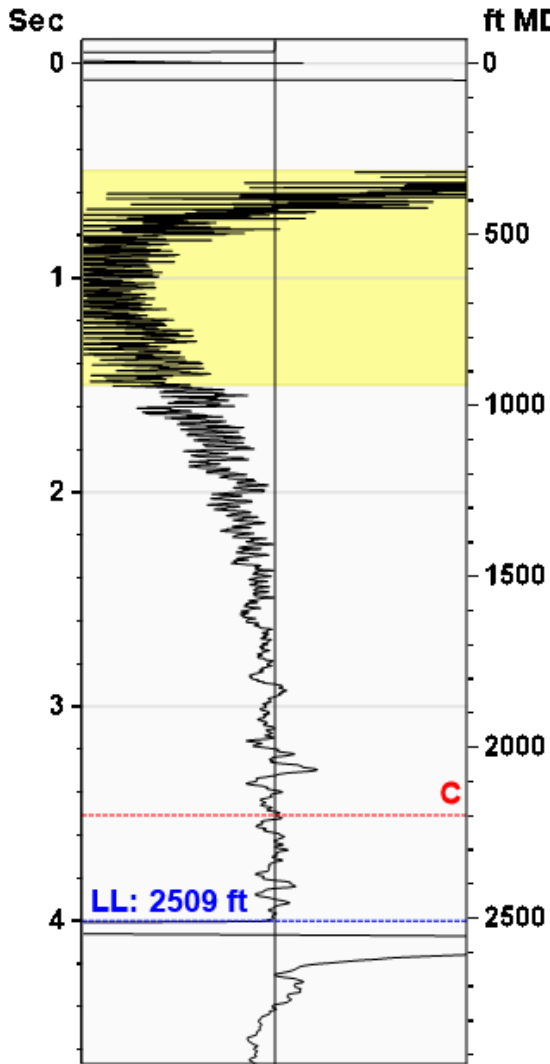

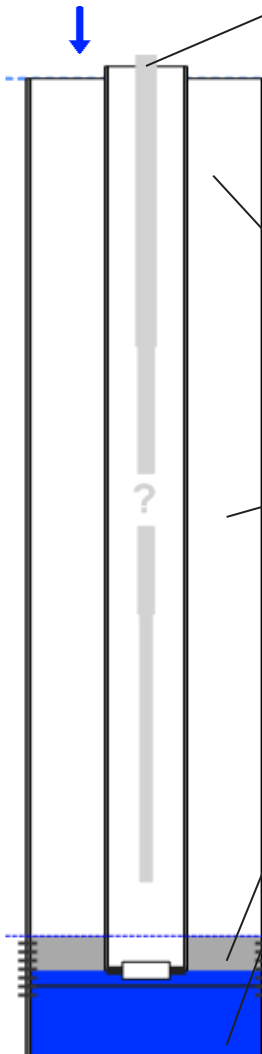


Liquid Level **2509 ft MD**

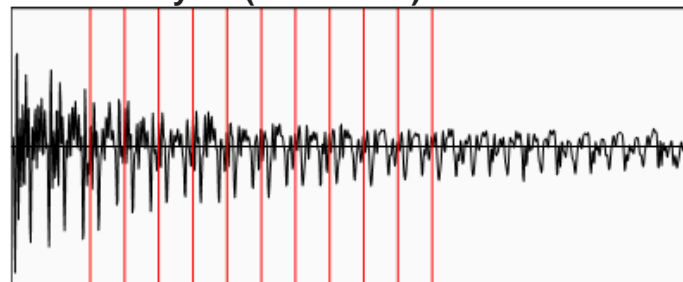

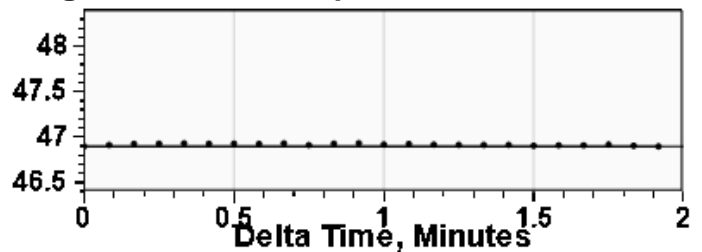
