
NOW THEREFORE, This agreement shall constitute a Bill of Sale for the Open Hole as above described.

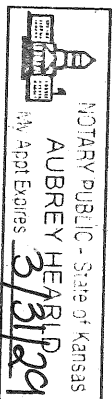

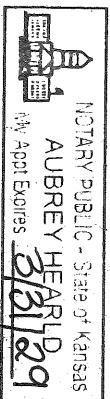
