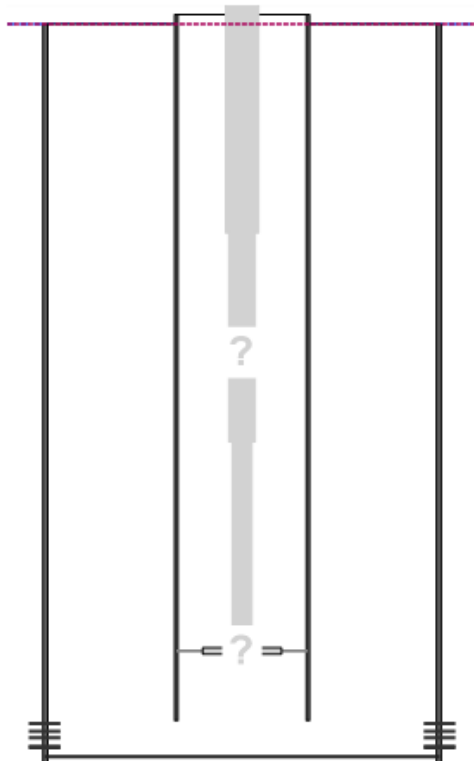

Producing Shot Manual Input



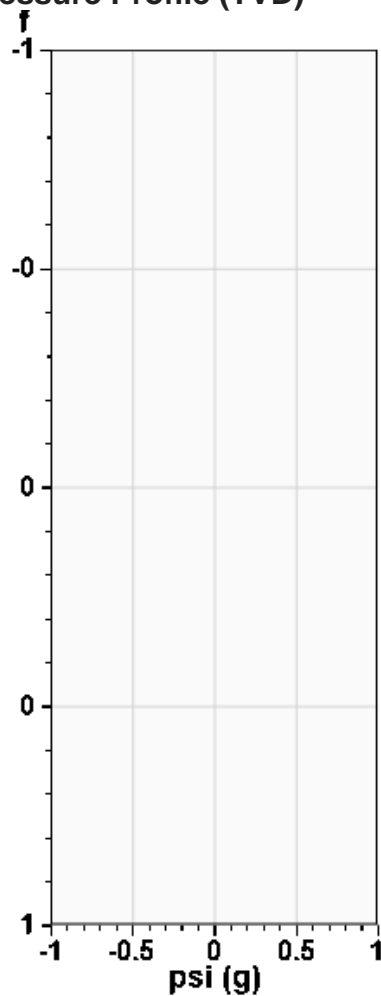

Pressure Profile (TVD)



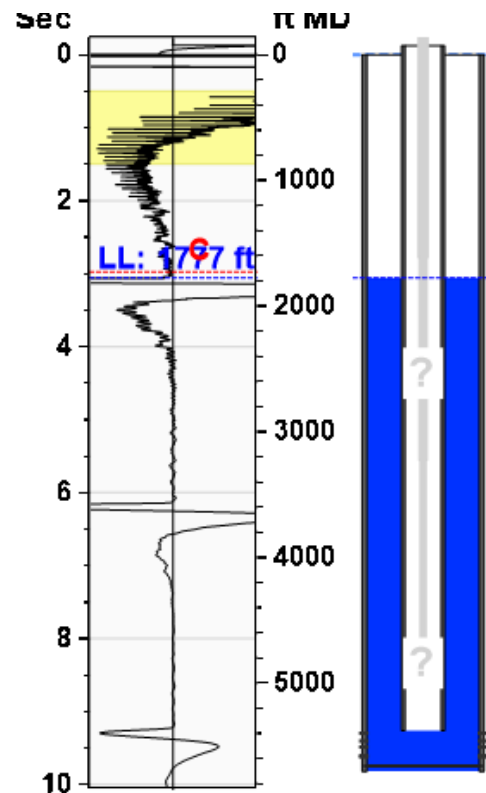

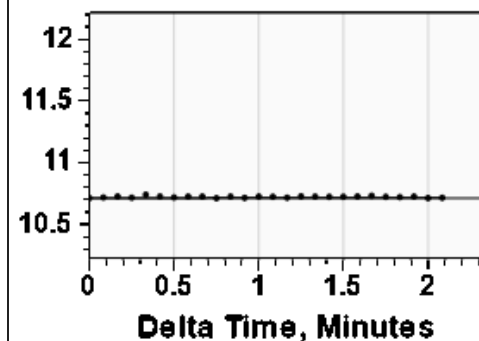
