
## TRANSFER OF OPERATOR RESPONSIBILITY

## **ASSIGNMENT OF WORKING INTEREST IN OIL AND GAS LEASES AND RESERVATION OF OVERRIDING ROYALTY INTEREST**

For Good and Valuable Consideration, the receipt and sufficiency of which is hereby acknowledged, effective May 1, 2025 ("Effective Date"), **Black Gold Investments, LLC, Joey L. Hendrich, Trustee of the Joey and Laurie Hendrich Trust dated December 20, 2008, Presley Petroleum Co., Jason Brin and Megan Brin, Brody L. Hendrich, Trustee of the Brody L. Hendrich Irrevocable Trust dated January 24, 2025, and Audrey M. Werth** (collectively, "Assignor") sells, assigns, and conveys unto **HG Oil Holdings, LLC** ("Assignee") all of Assignor's working interest, subject to the Reserved ORRI (defined below), in and to the:

- (a) oil and gas leases ("Leases") described in Exhibit "A";
- (b) oil, gas, injection and disposal wells ("Wells") described in Exhibit "B"; and
- (c) oil and gas agreements ("Agreements") described in Exhibit "C";

which Leases, Wells, and Agreements shall be collectively referred to herein as the "Properties", and shall include of all of Assignor's interest in all equipment and inventory associated, appurtenant, or used or obtained in connection with the operation of the Properties and which is situated on the land covered by the Properties, including but not limited to wellheads, tanks, pumps, compressors, separators, heater treaters, valves, fittings, equipment, machinery, fixtures, flowlines, pipelines, platforms, tubular goods, materials, tools, supplies, and all oil in stock on the Properties as of the Effective Date.

*Reserved ORRI.* Each Assignor hereby reserves as an overriding royalty interest of all the oil and gas produced, saved, marketed and sold from each Lease ("Reserved ORRI") the percentage equal to the difference between the lessor's royalty interest in the Leases and all overriding royalty interests and similar non-cost bearing burdens burdening the Leases of record, and 80.00%. The Reserved ORRI shall be proportionately reduced to the extent the working interest delivered in each Lease by each Assignor to Assignee is less than a 100% working interest. To the extent any Lease covers less than the full and entire undivided mineral interest to the lands covered thereby, then the Reserved ORRI in said Lease shall be further reduced in the proportion that the mineral interest leased bears to the whole and undivided mineral interest of the lands covered by the Lease. The Reserved ORRI shall be delivered free and clear of any and all costs and expenses of development, operation, exploration, transportation, and marketing, whatsoever,

excepting costs and expenses properly chargeable to the lessor's royalty share under the Leases, and severance, ad valorem and other taxes that may be levied or assessed against the production attributable to the Reserved ORRI and the proceeds thereof. In the event the Leases assigned hereunder are or become unitized, the ORRI shall be reduced or increased in the same proportion that the working interest share of production of unitized substances attributable to the Leases is reduced or increased, and the Reserved ORRI shall share in the production of unitized substances on the same basis as the working interest share from the Leases and from other oil and gas leases or mineral interests unitized with said Leases.

*Special Warranty.* Each Assignor warrants it is assigning and conveying the Properties free of claims of any other person by, through, or under Seller, but not otherwise, and further warrants the Properties are being assigned and conveyed to Assignee free and clear of all liens, mortgages, security interests or other such encumbrances, nor shall any mortgage, lien, or other encumbrance later arise from the conduct of the Assignor after the Effective Date, and that Assignor holds good and marketable title to not less than the working interest in the Properties entitled to the net revenue interest shown on Exhibit "A", and further warrants that the Properties are fit for their intended purposes and in a condition that enables them to be used in the ordinary course of business.

*Purchase and Sale Agreement.* This instrument is made pursuant to that certain Purchase and Sale Agreement dated April 15, 2025, entered into by and between Patterson Energy, LLC, as operator, Assignor as seller, and Assignee as buyer, the terms, conditions, representations, warranties and covenants of which are hereby incorporated into the body of this instrument by this reference.

This instrument may be executed in one or more counterparts with the same effect as if all signatures of the parties hereto were on the same document but in such event each counterpart shall constitute an original, and all of such counterparts shall constitute one instrument. Assignee is hereby authorized and empowered to assemble all such separate counterparts into a single instrument, and to file the same of record. This instrument shall extend to and be binding upon the heirs, successors and assigns of the parties hereto.

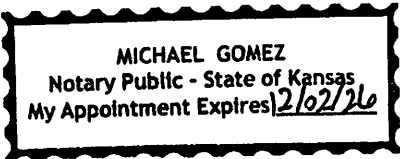



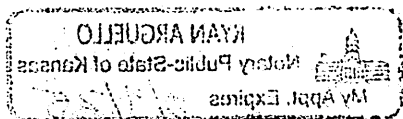
