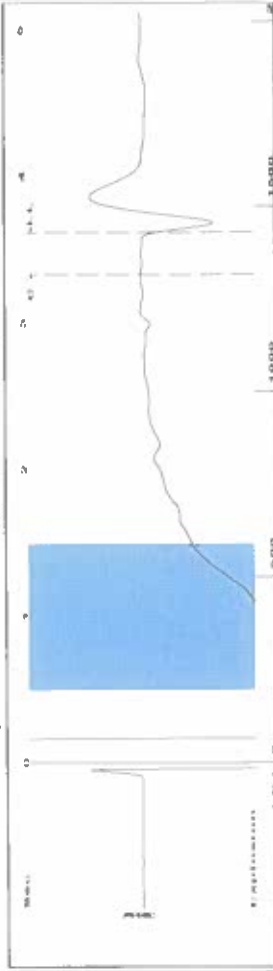

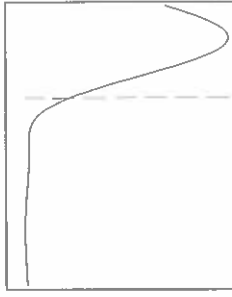
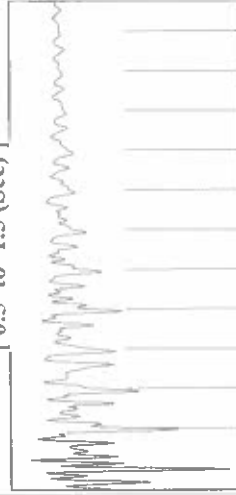

Casing Pressure Buildup

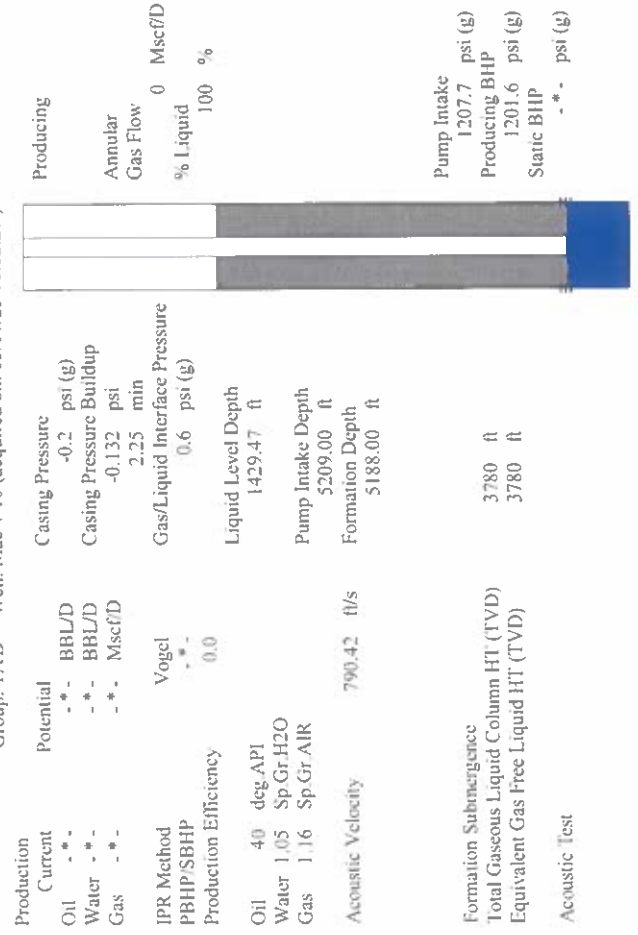

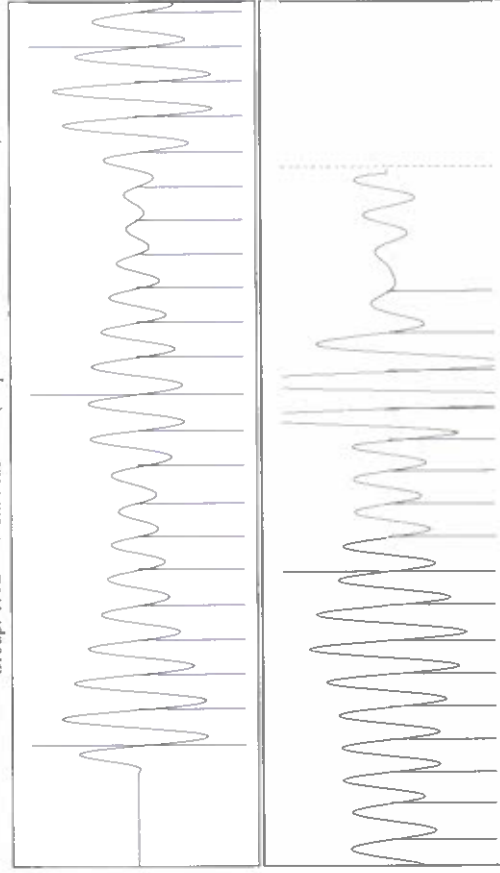
