Comanche County, KS

- 3/12/25 MIRU (Rawhide). Pulled rods and tubing.  
Wednesday
- 03/13/25 Set CIBP @ 6183' (EXCEL) w/ 2 sxs of cement dump-bailed on the CIBP.. RD  
Thursday (Rawhide) & RU Sargent & Lillard.
- 03/14/25 Down due to high winds.  
Friday
- 03/15/25 Down (Weekend)  
Saturday
- 03/16/25 Down (Weekend)  
Sunday
- 03/17/25 RU jacks, determined a free point, and shot the 4 1/2' Casing @ 2526'. Pulled 60 jts  
Monday of casing and ran tubing in to 720'. Will plug in AM.
- 03/18/25 Circulated the hole w/ 46 bbls of drilling mud and prepared to pump the 1st piug:  
Tuesday 1st Plug @ 720' w/ 50 sxs of Class A (common) w/ 3% cc. Pulled tubing up to 360'.  
2nd Plug @ 360' w/ 40 sxs of Class A (common). Pulled tubing up to 60'.  
3rd Plug @ 60' w/ 20 sxs of Class A (common). Had good cement returns @ the  
surface. Pulled remaining tubing. Cleaned the cellar, cut the head off (4' below  
GL), and cement is standing full. Cut and capped the 8 5/8" casing.
