Liquid Level

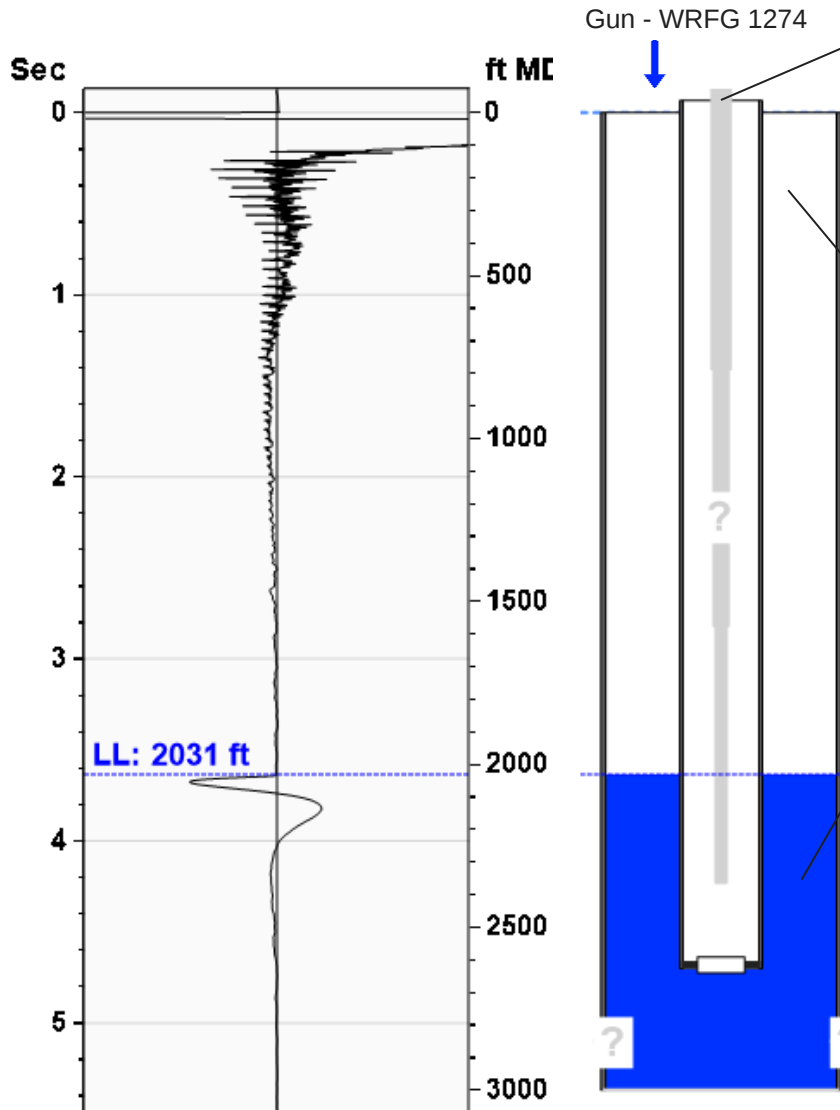

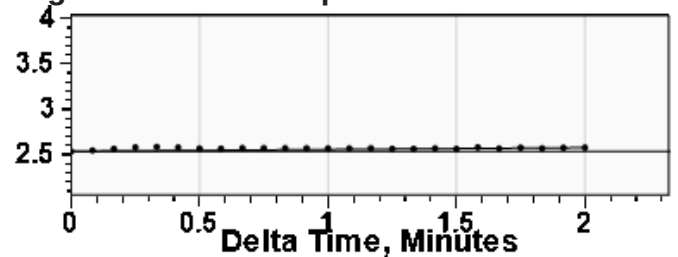
