ASSIGNMENT, CONVEYANCE AND BILL OF SALE  
(Barber, Edwards, Kiowa, Pawnee, Pratt, Stafford Counties, Kansas)

This Assignment, Conveyance and Bill of Sale (“*Assignment*”) is effective for all purposes as of 7:00 a.m. local time on August 23, 2022 (“*Effective Time*”), by TOTO ENERGY, LLC, Inc., a Delaware limited liability company (“*Assignor*”), and Aspen Riverdance Energy Fund, LLC, a Kansas limited liability company (“*Assignee*”). Assignor and Assignee are hereinafter referred to individually as “*Party*” and collectively as “*Parties*.”

Assignor, for valuable considerations, the receipt and sufficiency of which are hereby acknowledged, does by these presents GRANT, DEED, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER and DELIVER unto Assignee, seventy-five per cent (75%) of all of Assignor's right, title and interest in and to the following assets and properties, but excluding and reserving unto Assignor the Excluded Assets (such properties, after giving effect to such exclusion and reservation, the “*Properties*”):

(a) All fee interests in Hydrocarbons, and any and all property and rights incident thereto, including under grant deeds, mineral deeds, conveyances or assignments, as described on **Exhibit A**, or otherwise owned by Assignor, together with corresponding surface and subsurface interests in and to all the lands, property and rights incident thereto (collectively, “*Fee Interests*”), including all rights in any pooled or unitized or communitized acreage relating thereto (“*Fee Units*”); all production from the Fee Units; and all royalty interests, overriding royalty interests, reversionary interests, carried interests, options, convertible interests and net profits interests attributable to such Oil and Gas Properties (as defined below), together with all rights that arise by operation of Laws or otherwise in all properties and land unitized, communitized or pooled with any of the Fee Interests or Lands (as defined below); all Hydrocarbons production in storage at the Effective Time, and the proceeds therefrom;

(b) All Hydrocarbon leases, and the surface and subsurface leasehold estates created thereby, described in **Exhibit A**, or otherwise owned by Assignor (the “*Leases*”), and all of the lands covered by the Leases (any lands referenced in this clause (b) or clause (a) above are hereinafter collectively referred to as the “*Lands*”), together with corresponding surface and subsurface interests in and to all the lands, property and rights incident thereto, including all rights in any pooled or unitized or communitized acreage relating thereto (“*Lease Units*”); all production from the Lease Units; and all royalty interests, overriding royalty interests, reversionary interests, carried interests, options, convertible interests and net profits interests attributable to such Oil and Gas Properties, together with all rights that arise by operation of Laws or otherwise in all properties and land unitized, communitized or pooled with the Leases or Lands;

(c) All surface fee interests, easements, rights-of-way, servitudes, licenses, authorizations, pass through rights, permits, rights of use and all other surface and other rights and interests applicable to, or used or useful in connection with, any or all of the Oil and Gas Properties (the “*Surface Interests*”);

(d) All producing, non-producing, shut-in and other well bores including Hydrocarbon wells, disposal wells, injection wells, observations wells, co-op wells and water wells located on the Lands or attributable to the Oil and Gas Properties, including the wells described in **Exhibit A** and the pro-ration units associated therewith (the “*Wells*”);

(e) All pipelines, plants, gathering and processing systems, buildings, stations, compressors, pumps, piping and pipe inventory, remote and other automation equipment (including SCADA equipment and transmitters, telecommunications equipment, field radio telemetry and associated frequencies and licenses, pressure transmitters and central processing equipment that is used primarily in connection with the ownership or operation of the Oil and Gas Properties), machinery, tools, utility lines, equipment, fixtures, and

improvements and other appurtenances on or to the Oil and Gas Properties, insofar as they are used or used or held for use primarily in connection with the ownership, operation, maintenance or repair of the Oil and Gas Properties or the production, treatment, sale, transportation, or disposal of Hydrocarbons or water produced from the Oil and Gas Properties ( the “**Facilities**”);

(f) All Hydrocarbons (or the proceeds from the sale of Hydrocarbons) (a) produced from and after the Effective Time or (b) located as of the Effective Time in pipelines or in tanks, in each case, attributable to the Oil and Gas Properties;

(g) All farmout and farmin agreements, operating agreements, production sales and purchase contracts, processing contracts, gathering contracts, transportation contracts, saltwater disposal agreements, surface leases, balancing contracts, and all other instruments covering or affecting any or all of the Oil and Gas Properties, including, without limitation, Assignor’s rights to terminate any applicable joint operating or other agreements(the “**Contracts**”);

(h) All unitization, communitization and pooling declarations, orders and agreements to the extent they relate to the Oil and Gas Properties, or the production of Hydrocarbons therefrom;

(i) To the extent assignable, (a) all environmental and other governmental (whether federal, state, local or tribal) certificates, consents, permits (including conditional use permits), licenses, orders, authorizations, franchises and related instruments or rights relating to the ownership, operation or use of the Oil and Gas Properties, and (b) credits or the right to create credits or other transferable rights relating to past or future emissions reductions, in each case that were generated from the ownership, use or operation of the Oil and Gas Properties (the “**Permits**”);

(j) All royalties, overriding royalties, sliding scale royalties, shut-in royalties, rights to royalties in kind, or other interests in production of Hydrocarbons (other than working interests) arising out of or relating to any of the Oil and Gas Properties, including, without limitation, those set forth on **Exhibit A**;

(k) All partnership interests (tax, state law or otherwise) affecting any Oil and Gas Properties;

(l) To the extent assignable, all rights to indemnities and releases from third parties relating to the Oil and Gas Properties, Surface Interests, Wells or Facilities, in each case, to the extent relating to liabilities that Buyer has assumed or for which it owes an indemnification obligation hereunder;

(m) To the extent assignable, all insurance proceeds under existing policies of insurance, if any, relating to the Oil and Gas Properties, Surface Interests, Wells or Facilities, in each case, to the extent relating to liabilities that Buyer has assumed or for which it owes an indemnification obligation hereunder;

(n) The Records;

(o) Suspense Funds, to the extent provided in Section 7.11 of the of the Purchase Agreement; and

(p) All other assets and properties of Assignor used or held for use primarily in connection with the Oil and Gas Properties and the production of Hydrocarbons from the Oil and Gas Properties.

For purposes of this Assignment, (i) “**Hydrocarbons**” means oil, gas, natural gas liquids, condensate, casinghead gas and other liquid or gaseous hydrocarbons (or any combination or constituents thereof), any other minerals of every kind or character, and carbon dioxide, sulfur, helium and nitrogen, and (ii) “**Oil and Gas Properties**” means any or all of the Fee Interests, Fee Units, Leases, Lease Units, Lands, or Wells.

TO HAVE AND TO HOLD all of the Properties, together with all rights, titles, interests, estates, remedies, powers and privileges thereunto appertaining unto Assignee and its successors, legal representatives and assigns forever, subject to any Permitted Encumbrances and the terms of this Assignment.

This Assignment is subject to that certain Purchase and Sale Agreement dated as of August\_\_\_\_, 2022 (as such has or may hereinafter be supplemented, modified or amended from time to time, the “*Purchase Agreement*”) between Assignor and Assignee. The terms and conditions of the Purchase Agreement are incorporated herein by reference, and to the extent of a conflict between the provisions of the Purchase Agreement and this Assignment, the provisions of the Purchase Agreement shall govern and control. Capitalized terms used herein but not defined herein shall have the meanings assigned to such terms in the Purchase Agreement.

Assignor hereby excludes from the Assets and reserves unto Assignor all right, title and interest in and to the Excluded Assets.

Subject to the terms and conditions of the Purchase Agreement, Assignor hereby agrees to pay, perform, fulfill and discharge all Seller Parties Retained Liabilities and agrees to indemnify, defend and hold harmless Assignee and the Buyer Group from and against any and all Claims actually incurred or suffered by any of the Assignee or Buyer Group as a result of, relating to or arising out of the Seller Parties Retained Liabilities.

Subject to the terms and conditions of the Purchase Agreement, Assignee hereby assumes and agrees to pay, perform, fulfill and discharge all Buyer Assumed Liabilities and agrees to indemnify, defend and hold harmless Assignor from and against any and all Claims actually incurred or suffered by Assignor as a result of, relating to or arising out of the Buyer Assumed Liabilities.

FROM AND AFTER CLOSING, ASSIGNOR WARRANTS DEFENSIBLE TITLE UNTO ASSIGNEE AGAINST EVERY PERSON WHOMSOEVER LAWFULLY CLAIMING OR TO CLAIM THE SAME OR ANY PART THEREOF BY, THROUGH OR UNDER ASSIGNOR AND ITS AFFILIATES BUT NOT OTHERWISE, SUBJECT, HOWEVER, TO THE PERMITTED ENCUMBRANCES (SUCH WARRANTY, THE “SPECIAL WARRANTY”).

This Assignment shall be binding upon and inure to the benefit of the Parties and their respective heirs, assigns, successors and transferees.

This Assignment is made with full substitution and subrogation of Assignee in and to all covenants and warranties by others to Assignor heretofore given or made in respect of the Properties or any part thereof.

This Assignment shall be governed and construed in accordance with the Laws of the State of Kansas, without regard to the Laws that might be applicable under conflicts of laws principles.

Each Party consents to personal jurisdiction in any action brought in the United States federal and state courts located in the State of Texas and State of Colorado with respect to any dispute, claim or controversy arising out of or in relation to or in connection with this Assignment. EACH PARTY HEREBY IRREVOCABLY WAIVES, TO THE FULLEST EXTENT PERMITTED BY LAW, ANY OBJECTION WHICH THEY MAY NOW OR HEREAFTER HAVE TO THE VENUE OF ANY SUCH DISPUTE ARISING OUT OF THIS ASSIGNMENT BROUGHT IN SUCH COURTS OR ANY DEFENSE OF INCONVENIENT FORUM FOR THE MAINTENANCE OF SUCH DISPUTE.

EACH OF THE PARTIES AND THEIR RESPECTIVE SUCCESSORS AND ASSIGNS HEREBY IRREVOCABLY WAIVES ALL RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM (WHETHER BASED ON CONTRACT, TORT OR OTHERWISE) ARISING OUT OF OR RELATING TO THIS ASSIGNMENT, THE TRANSACTIONS CONTEMPLATED HEREBY OR THE ACTIONS OF ANY OTHER PARTY IN THE NEGOTIATION, ADMINISTRATION, PERFORMANCE AND ENFORCEMENT THEREOF.



## MEMORANDUM TO OPERATING AGREEMENT

THIS AGREEMENT, entered into by and between Wapiti Petroleum, LLC, a Texas limited liability company, hereinafter referred to as "Operator," and Aspen Riverdance Energy Fund, LLC, a Kansas limited liability company or parties other than Operator, hereinafter referred to individually as "Non-Operator," and collectively as "Non-Operators."

WHEREAS, the parties to this agreement are owners of Oil and Gas Leases and/or Oil and Gas Interests in the land identified in Exhibit "A" (said land, Leases and Interests being hereinafter called the "Contract Area"), and in any instance in which the Leases or Interests of a party are not of record, the record owner and the party hereto that owns the interest or rights therein are reflected on Exhibit "A";

WHEREAS, the parties hereto have executed an Operating Agreement dated June 1, 2025 (herein the "Operating Agreement"), covering the Contract Area for the purpose of exploring and developing such lands, Leases and Interests for Oil and Gas; and

WHEREAS, the parties hereto have executed this agreement for the purpose of imparting notice to all persons of the rights and obligations of the parties under the Operating Agreement and for the further purpose of perfecting those rights capable of perfection.

NOW, THEREFORE, in consideration of the mutual rights and obligations of the parties hereto, it is agreed as follows:

1. This agreement supplements the Operating Agreement, which Agreement in its entirety is incorporated herein by reference, and all terms used herein shall have the meaning ascribed to them in the Operating Agreement.

2. The parties do hereby agree that:

- A. The Oil and Gas Leases and/or Oil and Gas Interests of the parties comprising the Contract Area shall be subject to and burdened with the terms and provisions of this agreement and the Operating Agreement, and the parties do hereby commit such Leases and Interests to the performance thereof.
- B. The exploration and development of the Contract Area for Oil and Gas shall be governed by the terms and provisions of the Operating Agreement, as supplemented by this agreement.
- C. All costs and liabilities incurred in operations under this agreement and the Operating Agreement shall be borne and paid, and all equipment and materials acquired in operations on the Contract Area shall be owned, by the parties hereto, as provided in the Operating Agreement.
- D. Regardless of the record title ownership to the Oil and Gas Leases and/or Oil and Gas Interests identified on Exhibit "A," all production of Oil and Gas from the Contract Area shall be owned by the parties as provided in the Operating Agreement; provided nothing contained in this agreement shall be deemed an assignment or cross-assignment of interests covered hereby.
- E. Each party shall pay or deliver, or cause to be paid or delivered, all burdens on its share of the production from the Contract Area as provided in the Operating Agreement.
- F. The Oil and Gas Leases and/or Oil and Gas Interests which are subject hereto may not be assigned or transferred except in accordance with those terms, provisions and restrictions in the Operating Agreement regulating such transfers.  
  
This agreement and the Operating Agreement shall be binding upon and shall inure to the benefit of the parties hereto, and their respective heirs, devisees, legal representatives, and assigns, and the terms hereof shall be deemed to run with the leases or interests included within the lease Contract Area.
- G. All other matters with respect to exploration and development of the Contract Area and the ownership and transfer of the Oil and Gas Leases and/or Oil and Gas Interest therein shall be governed by the terms and provisions of the Operating Agreement.

This agreement shall be effective as of the date of the Operating Agreement as above recited. Upon termination of this agreement and the Operating Agreement and the satisfaction of all obligations thereunder, Operator is authorized to file of record in all necessary recording offices a notice of termination, and each party hereto agrees to execute such a notice of termination as to Operator's interest, upon the request of Operator, if Operator has complied with all of its financial obligations.

In the event of a conflict between the terms and provisions of this agreement and the terms and provisions of the Operating Agreement, then, as between the parties, the terms and provisions of the Operating Agreement shall control.

This agreement shall be binding upon each Non-Operator when this agreement or a counterpart thereof has been executed by such Non-Operator and Operator notwithstanding that this agreement is not then or thereafter executed by all of the parties to which it is tendered or which are listed on Exhibit "A" as owning an interest in the Contract Area or which own, in fact, an interest in the Contract Area. In the event that any provision herein is illegal or unenforceable, the remaining provisions shall not be affected, and shall be enforced as if the illegal or unenforceable provision did not appear herein.


