L&G OPERATING, LLC, a Kansas limited liability company (hereinafter referred to as "ASSIGNOR"), for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby grant, transfer, convey and assign unto INDEPENDENCE ENERGY LLC, a Kansas limited liability company (hereinafter referred to as "ASSIGNEE"), all ASSIGNOR's right, title and interest in and to the land, property and oil and gas interests (and all property covered thereby) described in Exhibit "A" attached hereto and made a part hereof (hereinafter referred to as the "Property").

The Property shall include all of ASSIGNOR's mineral fee and surface fee interests, leasehold interest, working interests, royalty interests, overriding royalty interests, interests in production, net profits interest, and all other interests, contracts, operating rights, and agreements in or associated with said Property further described on Exhibit "A".

It is agreed between ASSIGNOR and ASSIGNEE that this Assignment and Conveyance is made subject to the following:

The terms and conditions of the oil and gas leases, contracts and agreements included in the Property and ASSIGNEE hereby accepts and agrees to be bound by and to comply with all such terms and conditions.

Any and all valid and existing licenses, rights-of-way, easements, leases, grants, covenants, conditions, restrictions, exceptions and reservations affecting the Property.
