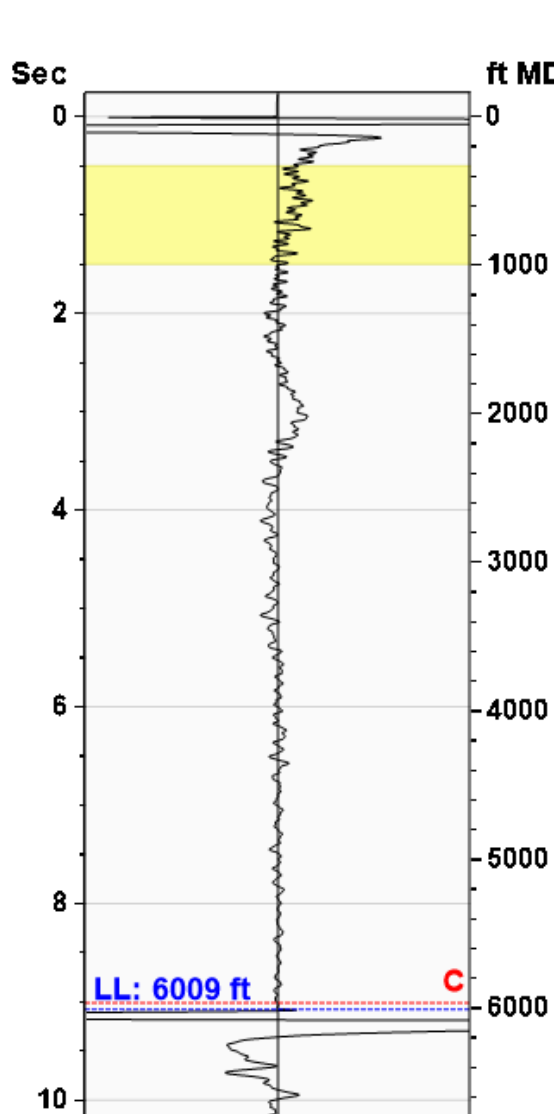


Liquid Level

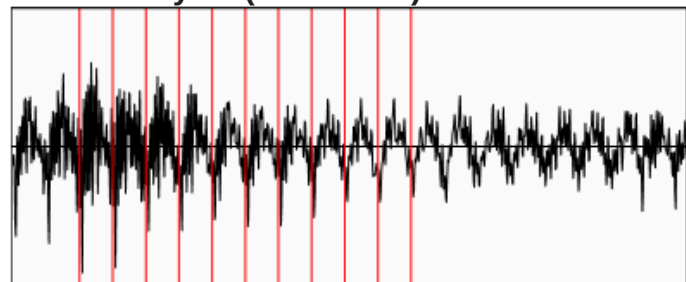

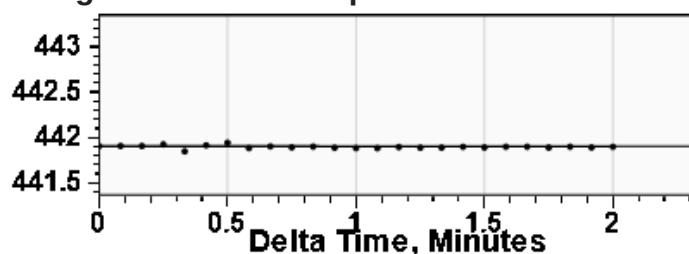
