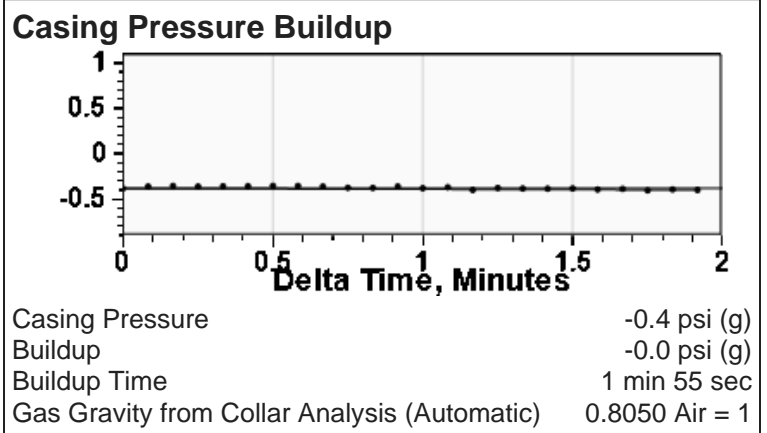
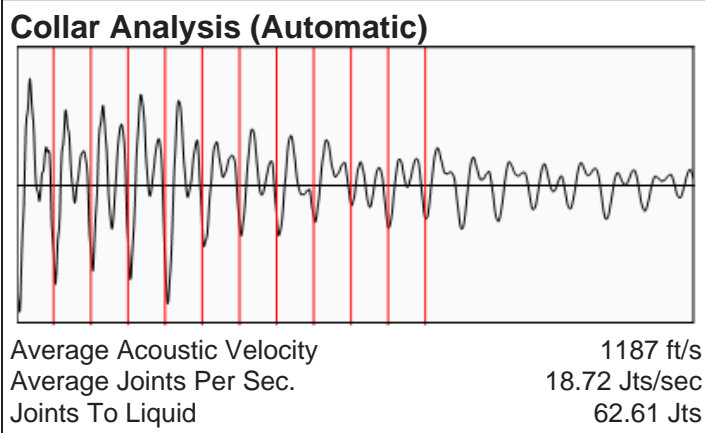


Liquid Level 1985 ft MD
