## ASSIGNMENT AND BILL OF SALE

MAR-LOU OIL COMPANY, LLC, hereinafter referred to as "Assignor", for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, do hereby grant, sell, convey and assign all of Assignor's right, title and interest in and to the working interest, the same being 100% of the working interest (the NRI is stated in Exhibit A), in and to the oil and gas leases described in Exhibit "A", attached hereto and incorporated herein by reference, to TIMOTHY F. SCHECK, as Trustee of the TIMOTHY F. SCHECK TRUST NO. 1, and all amendments to the same, hereinafter referred to as "Assignee" and the rights, privileges and estates given, created and granted under said leases, subject to the terms and conditions hereof and the terms and conditions of said leases, easements, surface leases and rights of way relating to operations pertaining to said properties and leaseholds, together with all of Assignor's right, title and interest in and to the leasehold equipment, material or personal property used exclusively for the operations of such assigned leasehold and located thereon, therein or appurtenant thereto, in its present condition. The assigned leasehold and other property and rights to be assigned are hereinafter sometimes referred to as "Assigned Assets".

This assignment is subject to all overriding royalties of record, including but not limited to overriding royalties owned of public record by Assignor, and made and accepted upon the following terms and conditions:

1. **Effective Time.** This assignment shall be effective on the 1st day of July, 2025, at 12:01 A.M., local time, for all purposes including apportionments of revenue, expenses and production, hereinafter referred to as the "Effective Time", regardless of the date of execution.

2. **Warranties.**

A. **Title.** THE ASSIGNOR COVENANTS WITH ASSIGNEE, HIS HEIRS, PERSONAL REPRESENTATIVES, BENEFICIARIES AND ASSIGNS, THAT THE ASSIGNOR IS THE LAWFUL OWNER OF AND HAS GOOD TITLE TO THE INTERESTS ABOVE ASSIGNED IN AND TO THE ASSIGNED ASSETS, LEASES, ESTATE, RIGHTS AND PROPERTY, FREE AND CLEAR FROM ALL LIENS, ENCUMBRANCES OR ADVERSE CLAIMS; THAT SAID LEASES ARE VALID AND SUBSISTING LEASES ON THE LAND DESCRIBED, AND ALL RENTALS AND ROYALTIES DUE THEREUNDER HAVE BEEN PAID AND ALL CONDITIONS NECESSARY TO KEEP THE SAME IN FULL FORCE HAVE BEEN DULY PERFORMED, AND THAT THE ASSIGNOR WILL WARRANT AND FOREVER DEFEND THE SAME AGAINST ALL PERSONS WHOMSOEVER, LAWFULLY CLAIMING OR TO CLAIM THE SAME.
