This letter shall serve as notification to the Kansas Corporation Commission and evidence that is the intent of Kansas Natural Gas Operating LC (KNGO) to transfer all well operations to EDISON OPERATING COMPANY, LLC, (EOC), and EOC accepts the responsibility of operations.

KNGO has been the operator of the wells described in detail on attached Exhibit "A" hereto. KNGO and EOC have entered into an Operating Agreement whereas EOC will assume operations. The effective time and date of the transfer shall be 12:00 a.m. (CST), July 1, 2025. A Kansas limited liability company was developed along with a Joint Operating Agreement for ownership management.
