Casing Pressure Buildup



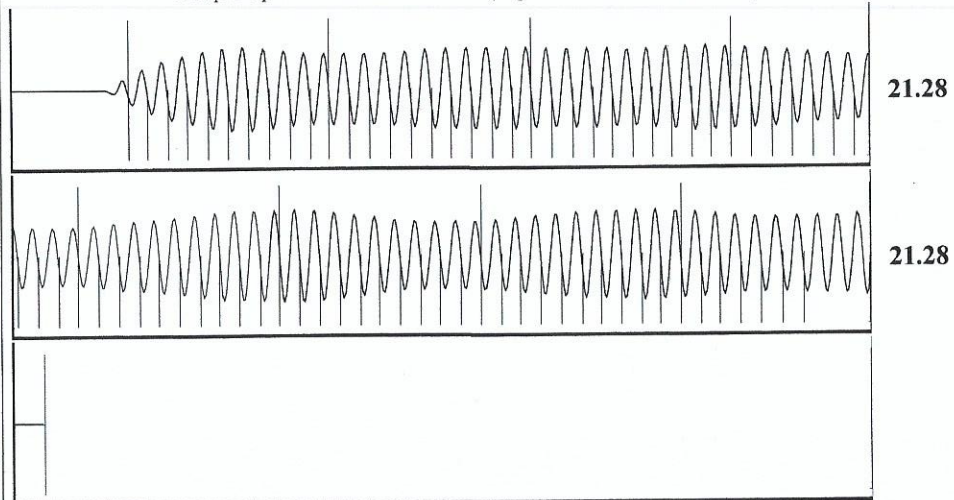
