**ASSIGNMENT OF OIL AND GAS LEASE**

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Andrew King, hereinafter called ASSIGNOR, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby sell, assign, transfer, set over and convey unto L&A Energy, LP, hereinafter called ASSIGNEE, a .875 revenue interest, which equals a 100% working interest, in and to the following oil and gas lease located in Woodson County, Kansas, to wit:

A certain oil and gas lease dated July 18<sup>th</sup>, 2005 executed by Dwight N. Jackson, as Lessor, to Joe Greer, Jr., Andrew King, and Charles King, all as Lessee, said lease being recorded in Book 86, at Page 370, insofar as said lease covers the following described land in Woodson County, State of Kansas:

The East Half of the Northwest Quarter (E2NW4), of Section Nineteen (19), Township Twenty-Six South (T26S), Range Seventeen East (R17E),


together with the rights of said oil and gas lease incident thereto and the personal property located thereon, appurtenant thereto, and used or obtained in connection therewith; including, but not limited to, all gathering lines, meters, pumps, tanks, fittings, connections, and all related equipment and machinery located in, on or across the above-described property.

ASSIGNOR further covenants with the ASSIGNEE, its successors or assigns: That ASSIGNOR is the lawful owner of the interest herein assigned in and to said lease, estates, rights and property, free and clear from all liens, encumbrances or adverse claims except those recorded of public record; and all royalties due thereunder have been paid.

ASSIGNOR does not warrant the physical condition of personal property relating to the above, and such personal property is conveyed "as is" in its present existing condition.


This assignment shall be binding upon the ASSIGNOR, ASSIGNEE and their respective successors and assigns.
