**AFFIDAVIT OF EQUITY INTEREST PURCHASE AGREEMENT**

This Affidavit of Equity Interest Purchase Agreement (“Affidavit”) is made effective as of May 1, 2025 (the “Effective Date”) by the undersigned authorized representative of Mach Natural Resources LP, a Delaware Limited Partnership, and BCE-Mach LLC, a Delaware Limited Liability Company, (collectively, “Purchaser”) both with an address of 14201 Wireless Way, Suite 300, Oklahoma City, Oklahoma 73134. The undersigned authorized representative of Purchaser desires to record this Affidavit to place third parties on notice of the following:

As of the Effective Date, XTO Energy Inc., a Delaware corporation with an address of 22777 Springwoods Village Parkway, Spring, Texas 77389 (the “Seller”) and Purchaser entered into a mutually agreed-upon Equity Interest Purchase Agreement (the “Agreement”).

WHEREAS, capitalized terms used in this Affidavit but not defined herein shall have the meanings given them in the Agreement.

WHEREAS, Seller is the owner of one hundred percent (100%) of the issued and outstanding equity interests of Ringwood Gathering Company, a Delaware corporation (“Ringwood”), Timberland Gathering & Processing Company, Inc., a Texas corporation (“Timberland”) and XTO HT WyKsOk, LLC, a Delaware limited liability company (“WyKsOk”);

WHEREAS, subject to the terms and conditions of the Agreement and pursuant to the Equity Interest Assignment Agreement attached as Exhibit A, Purchaser has acquired all of the assets and properties owned or leased by Ringwood, Timberland and WyKsOk, including Ringwood’s, Timberland’s and WyKsOk’s right, title and interest in and to the following assets located within the Sale Area set forth in Exhibit C attached hereto:

- (a) all oil and gas leases described in Exhibit B-1 or located within the Sale Area, and all rights incident thereto and derived therefrom, including overriding royalty interests, net profits interests, and other revenue interests therein (the “Leases”);
- (b) all mineral interests described in Exhibit B-2 or located in the Sale Area (the “Mineral Interests”);
- (c) all wells (including all disposal, water, or injection wells) located on the Leases, Mineral Interests or Units, including those described in Exhibit B-3, whether such wells are producing, shut-in or abandoned;

- (d) all rights and interests in, under or derived from all unitization or pooling agreements in effect with respect to any of the Leases and units created thereby (the "Units");
- (e) the Existing Contracts to the extent used in connection with the ownership of the Leases, Mineral Interests, Wells, or Units as of the Effective Date; and
- (f) all Hydrocarbons attributable to the Leases, Mineral Interests, Wells and/or Units after the Effective Date.

NOW THEREFORE, Purchaser desires to place third parties on notice of the Agreement.

## Exhibit A

**EQUITY INTEREST ASSIGNMENT AGREEMENT**

This EQUITY INTEREST ASSIGNMENT AGREEMENT (this "Assignment"), dated as of 12:00:01 a.m. Central Time on May 1, 2025 (the "Effective Time"), is made by and between XTO Energy Inc., a Delaware corporation ("Assignor"), and BCE-Mach LLC, a Delaware limited liability company ("Assignee"). Assignor and Assignee are referred to herein, collectively, as the "Parties" and each, individually, as a "Party".

**WITNESSETH:**

WHEREAS, Assignor owns one hundred percent (100%) of the issued and outstanding equity interests of Ringwood Gathering Company, a Delaware corporation ("Ringwood"), Timberland Gathering & Processing Company, Inc., a Texas corporation ("Timberland") and XTO HT WyKsOk, LLC, a Delaware limited liability company ("WyKsOk" and together with Ringwood and Timberland, collectively referred to herein as the "Companies" and singularly as a "Company", and such interests, the "Equity Interests");

WHEREAS, pursuant to that certain Equity Interest Purchase Agreement, dated as March 25, 2025 by and between Assignor and Assignee (the "Purchase Agreement"), Assignor agreed to assign the Equity Interests to Assignee as of the Effective Time;

WHEREAS, Assignor desires to effect the assignment, transfer, conveyance and delivery of the Equity Interests to Assignee, and Assignee desires to accept, the Equity Interests of Assignor, pursuant to the terms of this Assignment and the Purchase Agreement; and

WHEREAS, this Assignment is being executed and delivered by Assignor and Assignee as of the Effective Time.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and confessed, the Parties do hereby agree as follows:

1. Assignment. Assignor hereby assigns, transfers, conveys and delivers to Assignee, and Assignee hereby assumes and accepts, Assignor's entire right, title and interest in and to the Equity Interests, free and clear of any Encumbrances (other than Encumbrances arising pursuant to or described in the Purchase Agreement, the Organizational Documents of the Companies or applicable securities Laws).

2. Resignation of Officers, Directors and Managers of Ringwood and Timberland. Upon execution and delivery hereof by the Parties as of the Effective Time, the Parties hereby acknowledge and agree that all of the officers, directors and managers of each of Ringwood and Timberland resign as of even date herewith in accordance with Section 7.7 of the Purchase Agreement. The Parties agree that such resignation shall not dissolve either Ringwood or Timberland and the business of Ringwood and Timberland shall continue as set forth in each's respective bylaws.

3. Substitution as Sole and Managing WyKsOk Member. Upon execution and delivery hereof by the Parties as of the Effective Time, Assignee is hereby substituted for Assignor as the sole member of WyKsOk under the Limited Liability Company Agreement of WyKsOk,

dated as of the Effective Time (the “**WyKsOk LLC Agreement**”), and Assignor does hereby withdraw from WyKsOk as the sole member, and ceases to be the sole member of WyKsOk and ceases to have or exercise any right or power as the sole member of WyKsOk or in any regard with respect to the Equity Interests (including any rights or power associated with such Equity Interests). The Parties agree that the assignment of the Equity Interests, the admission of Assignee as the substitute sole member, and the cessation of Assignor as the sole member of WyKsOk shall not dissolve WyKsOk and the business of WyKsOk shall continue as set forth in the WyKsOk LLC Agreement.

4. General Provisions.

(a) Defined Terms. Capitalized terms used herein but not otherwise defined herein shall have the meaning ascribed to such terms in the Purchase Agreement.

(b) Governing Law. THIS ASSIGNMENT AND THE LEGAL RELATIONS AMONG ASSIGNOR AND ASSIGNEE SHALL BE GOVERNED AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS. EACH OF ASSIGNOR AND ASSIGNEE CONSENT TO THE EXERCISE OF JURISDICTION IN PERSONAM BY THE COURTS OF THE STATE OF TEXAS FOR ANY ACTION ARISING OUT OF THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.

(c) Counterparts. This Assignment may be executed in several counterparts, each of which shall be deemed an original and all of which shall together constitute one and the same instrument. This Assignment may be executed and delivered by email in portable document format (.pdf), and delivery of the executed signature page by such method will be deemed to have the same effect as if the original signature had been delivered to the other Parties.

(d) Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns.

(e) Assignment. This Assignment may be amended or modified in whole or in part only by a duly authorized agreement in writing which makes reference to this Assignment executed by all Parties.




