Casing Pressure Buildup



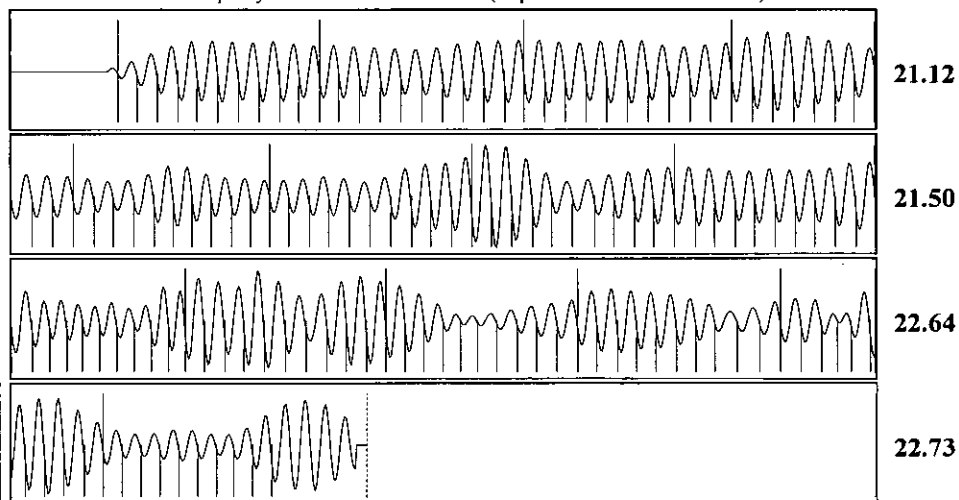
