ASSIGNMENT OF OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Andrew D. King (aka Andrew King), hereinafter called ASSIGNOR, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby sell, assign, transfer, set over and convey unto L&A Energy, LP, hereinafter called ASSIGNEE, a .875 revenue interest, which equals a 100% working interest, in and to the following oil and gas lease located in Woodson County, Kansas, to wit:

A certain oil and gas lease dated March 10th, 1995 executed by Noel L. Jackson and Julia A. Jackson, husband and wife, as Lessor, to Paul Baker and Mary Baker, as Lessee, said lease being recorded in Book 76, at Page 56, insofar as said lease covers the following described land in Woodson County, State of Kansas:

The West Half of the Northwest Quarter (W2 NW4) less and except ten (10) acres around an existing gas well in the Northwest Quarter (NW4) being 540 feet East and 690 feet South of the Northwest corner of said Northwest Quarter; and the North Half of the Southwest Quarter (N2 SW4); all in Section Nineteen (19), Township Twenty-Six South (T26S), Range Seventeen East (R17E) and containing 150 acres more or less,



ASSIGNOR does not warrant the physical condition of personal property relating to the above, and such personal property is conveyed "as is" in its present existing condition.

This assignment shall be binding upon the ASSIGNOR, ASSIGNEE and their respective successors and assigns.


