To Whom It May Concern:

The three remaining Jones wells are being transferred from Petrodome to JTC in order for JTC to file the proper paperwork and plug them. Petrodome's license is expired and they cannot file forms on KOLAR. A company called Petro Properties, which shares common management with JTC, bought all of Petrodome's leases. However, the Jones was no longer an active lease having been mostly plugged out and all equipment removed, so there is no assignment of it. If you look at production history on KGS, you'll see no production from the Jones lease (KDOR 116149) since 2019.
