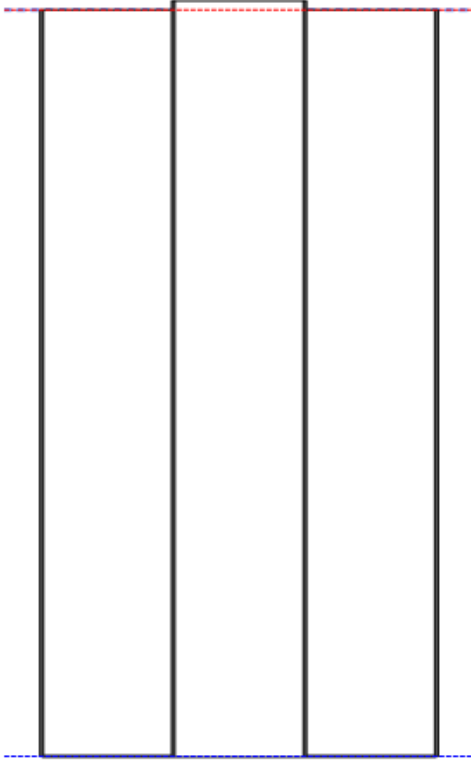

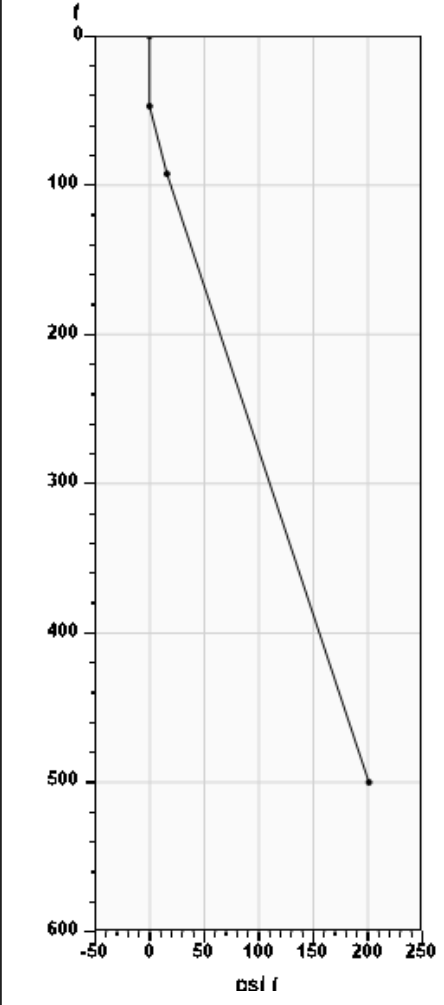

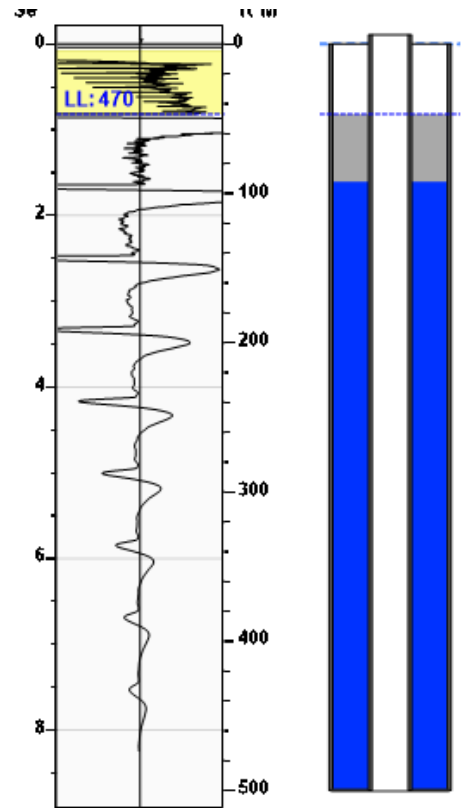

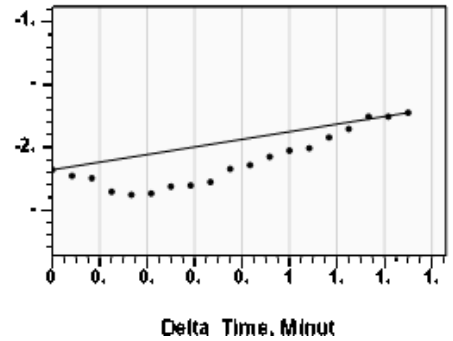
Pressure Profile (TVD)
