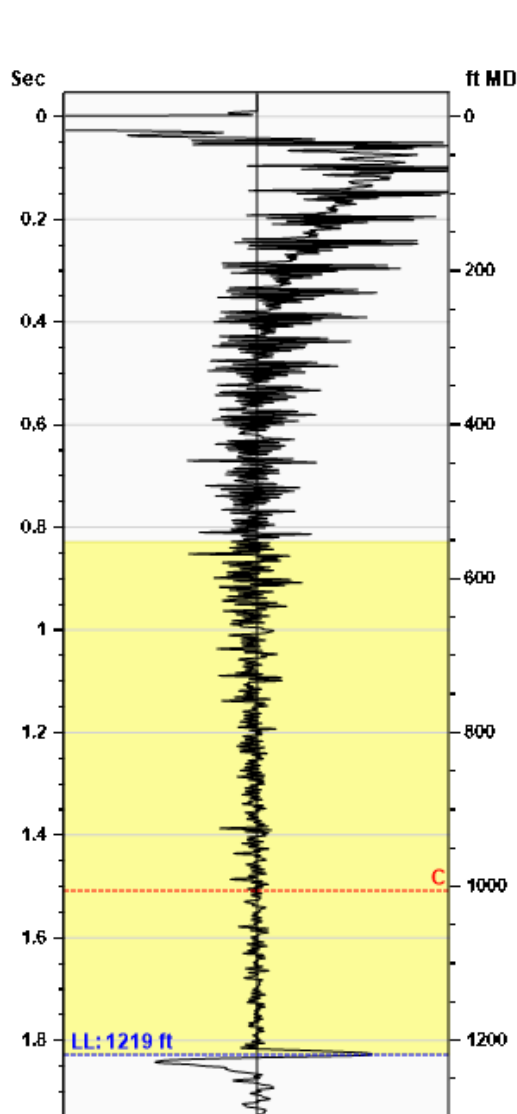

Liquid Level

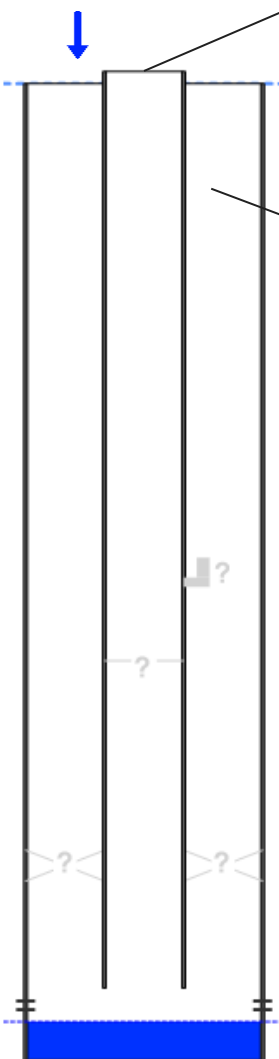

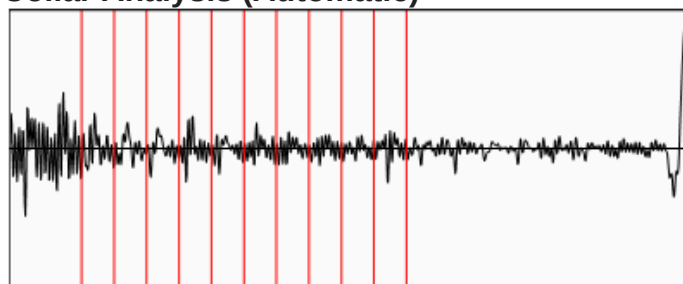

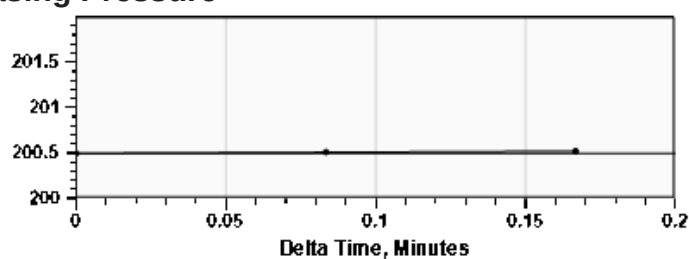
