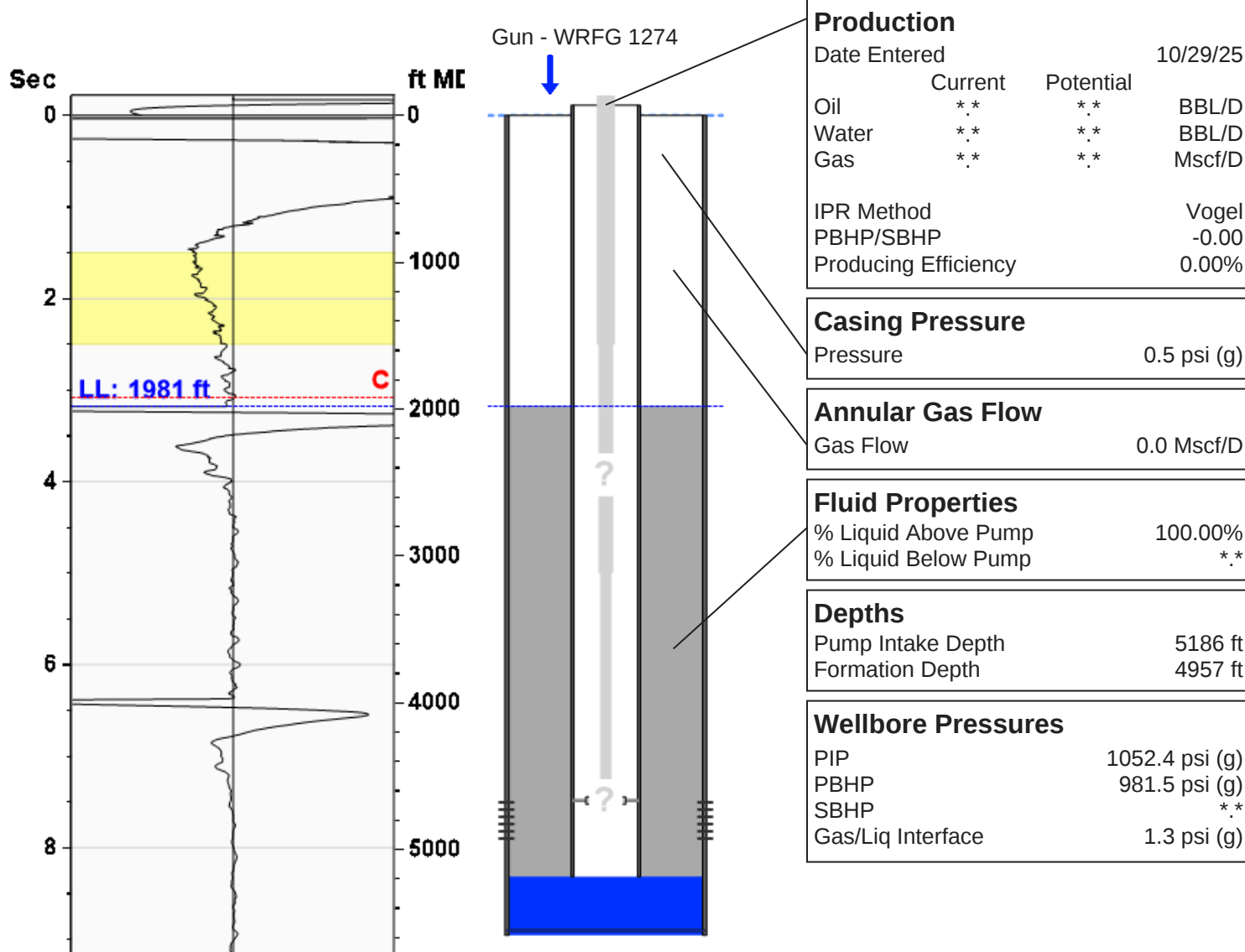

Fluid Above Pump

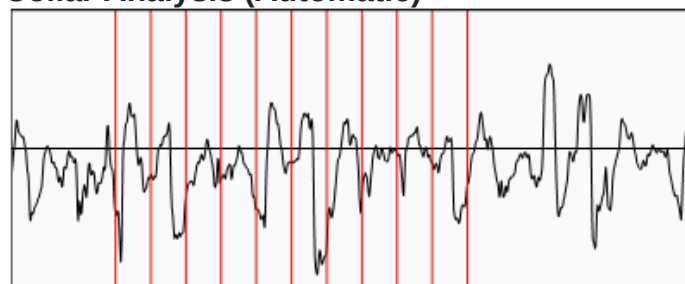
Equivalent Gas Free Above Pump

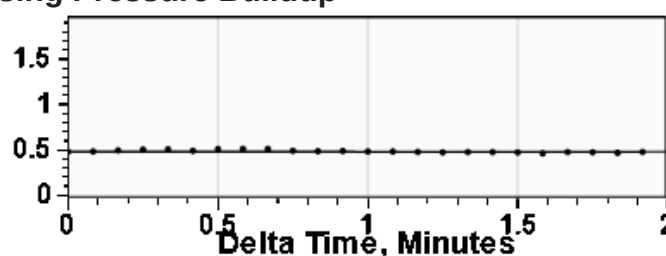


Collar Analysis (Automatic)
