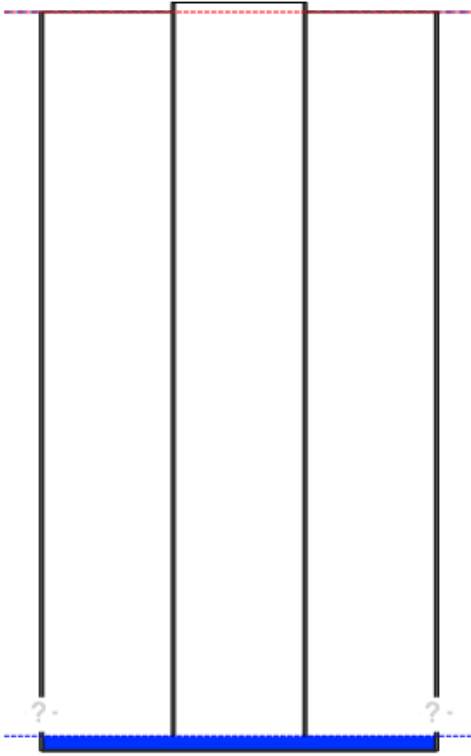

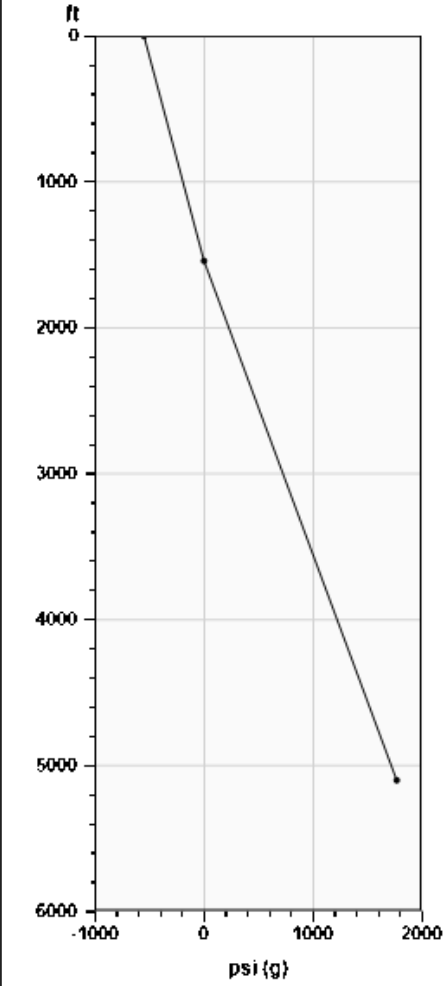

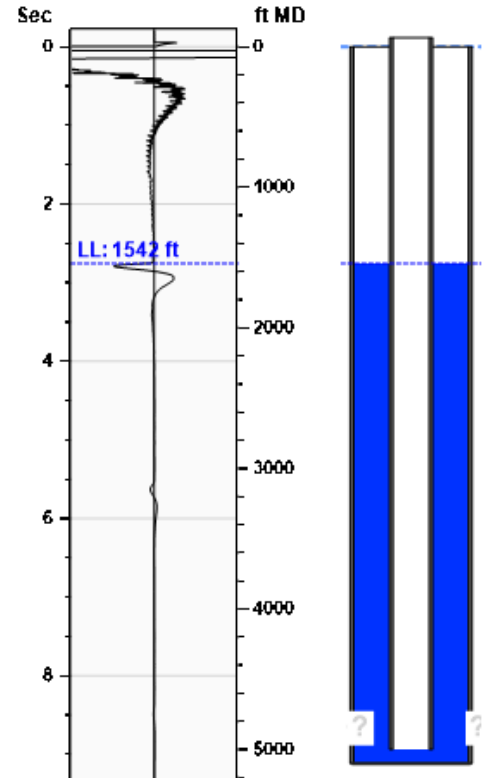
**Static Bottomhole Pressure

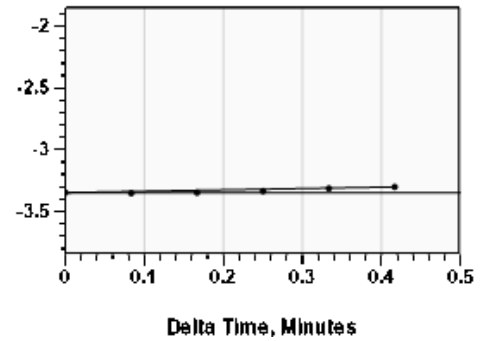
**Pressure Profile (TVD)**
