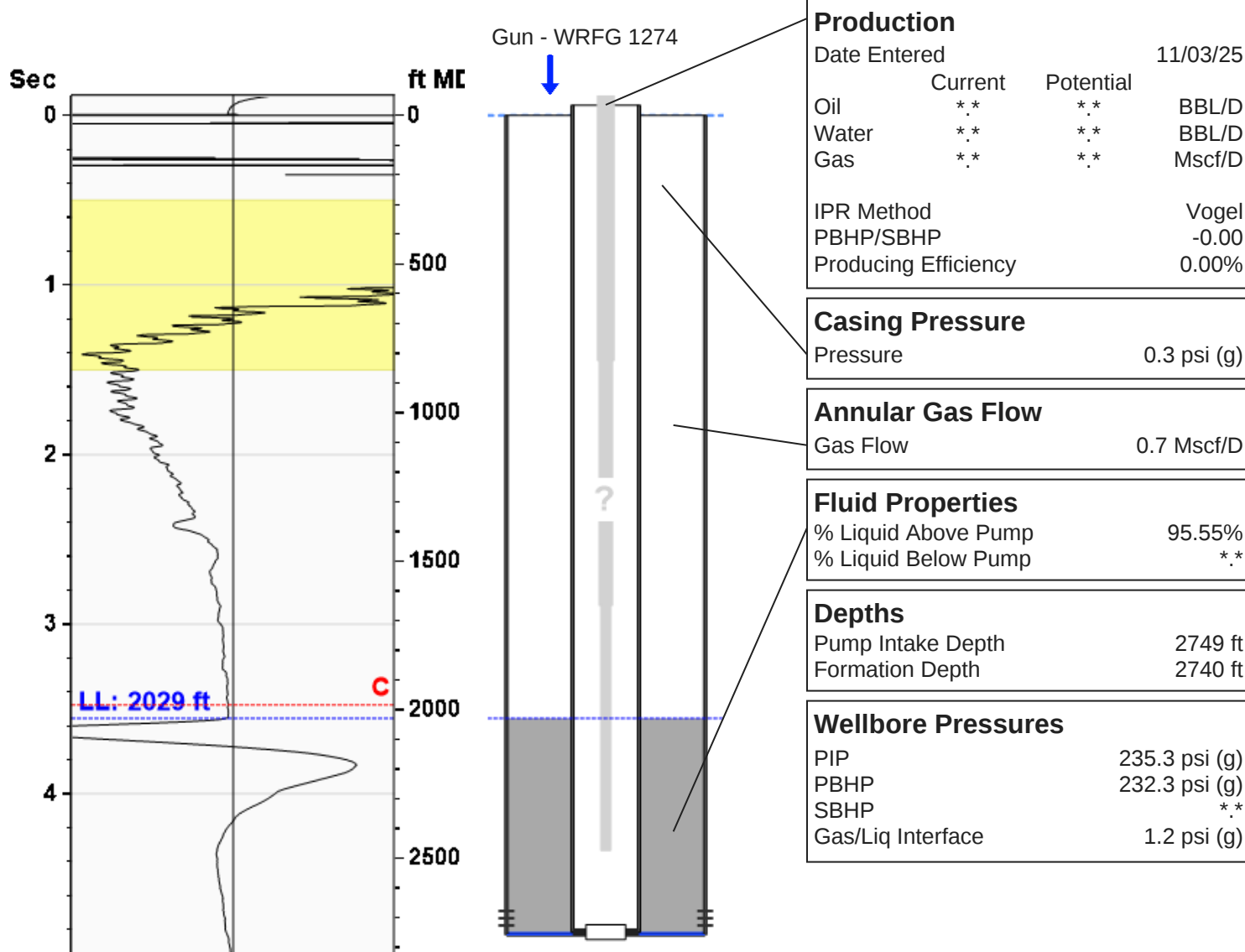

Fluid Above Pump

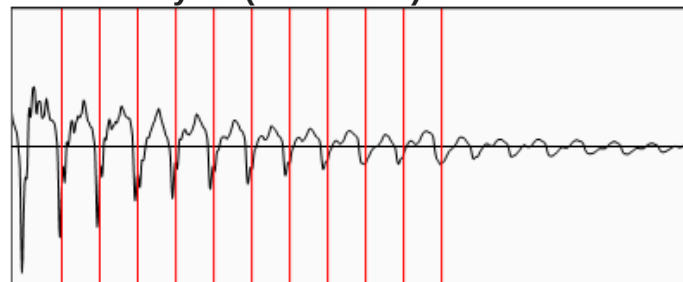
Equivalent Gas Free Above Pump

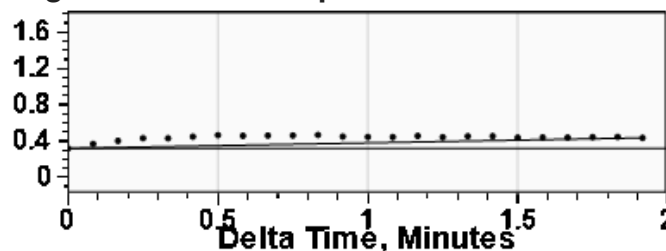
