AGREEMENT

1. Casey A. Lair and Julie L. Lair (Casey and Julie) are the owners of the following described property.

A. South Half of the Southwest Quarter (S/2 SW/4) of Section 5, Township 24S, Range 17E, Woodson County, Kansas.

2. Gregory D. Lair and Judith R. Lair (Greg and Judy) are the owners of the following described property.

Southeast Quarter (SE/4) of Section 6, Township 24S, Range 17E and the North Half of the Northwest Quarter (N/2 NW/4) of Section 5, Township 24S, Range 17E, Woodson County, Kansas.

3. There exists valid and producing Oil and Gas Leases upon the property described in paragraphs 1A and 2 above in which the Lessee's interest is held and owned by RJ Energy, LLC and the Lessor's interest is held by Casey and Julie and Greg and Judy.

4. Casey and Julie, along with Greg and Judy have consented to RJ Energy, LLC combining and comingling the oil being produced upon their leased properties by having said production collected, processed and marketed from one tank battery system located upon the adjoining property owned by Casey and Julie.

5. Casey and Julie, along with Greg and Judy have agreed (and hereby affirm and agree) to have all mineral rights, royalty interests and overriding royalty interests produced from their combined above described leased properties split between them with .25 (25%) going to Casey and Julie and .75 (75%) going to Greg and Judy. Presently the royalty interest and overriding royalty interest is equal to .1875 (18.75%) of all oil produced, marketed and sold from the combined properties, which results in Casey and Julie receiving .046875 (4.6875%) and Greg and Judy receiving .140625 (14.0625%) of all revenue from oil produced, marketed and sold therefrom.

This Agreement shall continue for as long as oil is being produced, marketed and sold from the combined properties and shall be binding upon the successors and assigns of the parties hereto.

This Agreement is effective as of January 1, 2025.
