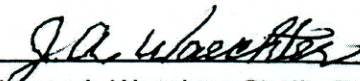

responsibilities, and or obligations of an Operator to Tatanka Operating -Kan LLC.

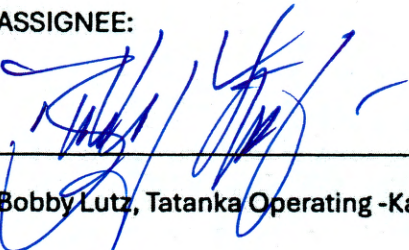
